Rules made by the Village Health Commission of Ormidhia in the District of Larnaca under Section 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, the Village Health Commission of Ormidhia hereby make the following rules:—

- 1. These rules may be cited as the Village Health (Ormidhia) Rules, 1954, and shall come into operation on their publication in the Gazette.
- 2.—(1) Subject to the provisions of paragraphs (2) and (3) of this rules, the Village Health (Nikos) Rules, 1952, published in Supplement No. 3 to the *Gazette* of the 19th November, 1952, shall—
 - (a) be deemed to be rules made by the Village Health Commission of Ormidhia and to be incorporated herein; and
 - (b) apply to the village of Ormidhia: provided that for the word "Nikos" and for the word "Nicosia" whenever they occur in the Model Rules, the word "Ormidhia" and the word "Larnaca" shall be substituted respectively.
- (2) The rules set out in Part I of the Schedule hereto shall be substituted for the corresponding rules of the Village Health (Nikos) Rules, 1952.
- (3) Those rules of the Village Health (Nikos) Rules, 1952, mentioned in Part II of the Schedule hereto, shall not apply to the village of Ormidhia.

THE IRRIGATION DIVISIONS (VILLAGES) LAW. CAP. 111.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Law, Cap. 111, the following rules made by the Committee of the Irrigation Division of Stavrokono, in the District of Paphos, are published in the Gazette.

IRRIGATION DIVISION OF STAVROKONO.

Rules.

- 1. These rules may be cited as the Irrigation Division of Stavrokono Rules, 1954.
- 2. In these rules, unless the context otherwise requires-
 - Commissioner" means the Commissioner of the District of Paphos.
 - "Committee" means the Committee of the Irrigation Division.
 "Irrigation Division" means the Irrigation Division of Stavrokono.
- "Law" means the Irrigation Divisions (Villages) Law, Cap. 111.
 "List" means the list of the names and residence of the proprietors and of the lands and extent thereof which are to be benefited or are capable of being benefited by the works prepared under the provisions of section 16 of the Law as finally settled.
 "Works" means the irrigation works of the Irrigation Division.
- 3. The Committee shall hold office for a period of three years beginning on the 11th July, 1954. Thereafter the election of the Committee shall take at the state of the committee shall be stated as the state of the committee shall be stated as the state of the committee shall be stated as the stated 1954. Thereafter the election of the Committee shall take place every third year in the first week of the month of July and it shall hold office for a period of three years from the day next following its election.
- 4.—(1) The Committee shall appoint a treasurer who shall collect the rates and charges assessed upon the proprietors mentioned in the list.
- (2) The treasurer shall, on the 31st October, in every year, prepare a statement of all rates or charges still due and unpaid on that date and shall forward such statement to the Commissioner.

 - (3) The treasurer shall be paid:—
 (a) a remuneration of 5% of all rates and charges collected by him.
- (b) such of his out of pocket expenses as may be sanctioned by the Committee. (4) The treasurer shall be appointed for such period as the Committee may fix but in no case extending over the term of office of the Committee appointing such treasurer.
- 5. Every proprietor mentioned in the list shall pay a rate not exceeding 30 shillings per annum as may be prescribed by the Committee from time to time for every Government donum of land owned by such proprietor which is benefited or is capable of being benefited by the works.
- 6. All rates assessed under the provisions of the Law and of these rules shall be paid on or before the 31st October, in every year.
- 7. The list shall be examined annually not later than the 1st day of March, in every year, by the Committee who shall have power to amend same as in section 16 (6) of the Law provided.
- 8. The annual estimates of the Irrigation Division shall be submitted by the Committee to the Commissioner for approval not later than the 1st day of March, in every year.
- 9. The Committee shall from time to time authorize the treasurer to pay out of the money in his hands any sum required-
 - (a) for the works or for the maintenance or repairs thereof;
 - (b) for any purpose approved by the Commissioner in connection with the operations of the Irrigation Division provision for which is made in any estimates approved by the Com-
 - (c) for any compensation payable under sections 32 to 34 of the Law, whenever there are funds at the disposal of the treasurer or of the Committee sufficient to meet any amount payable as compensation under the provisions of these sections.
