THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 79A.

Whereas it appears to the Governor to be essential, for the purpose of maintaining, controlling and regulating supplies and services so as to secure a sufficiency of those essentials to the well-being of the community, that the work of providing accommodation and food in hotels, and of providing food in restaurants, situate within the municipal limits of any municipal corporation within the Colony be declared as essential work for the purposes of Defence Regulation 70A:

Now, therefore, in exercise of the powers vested in him by Defence Gazette: Regulation 79A of the Defence Regulations (as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force under the provisions of the Supplies and Services (Continuance) Order, 1954) His Excellency the Governor has been pleased to make the following Order:

- 1. This Order may be cited as the Essential Works (Hotels and Restaurants) Order, 1954.
 - 2. In this Order—
 - "Commissioner" means the Commissioner of Labour and includes any person duly authorised by him in writing for the purposes of this
 - "essential work" means the work or service of providing accommodation and food in any hotel, or of providing food in any restaurant, situate within the municipal limits of any municipal corporation in the Colony and includes any other work or service connected therewith;
 - "specified person" means any person or any class or description of persons employed in the essential work.
 - 3. No specified person employed in the essential work shall-
 - (a) leave his employment at such work without the permission in writing of the Commissioner;
 - (b) absent himself from such work without a reasonable excuse to the satisfaction of the Commissioner;
 - (c) be persistently late in presenting himself for work without a reasonable excuse to the satisfaction of the Commissioner.

- 4. Any person carrying on the essential work shall permit the Commissioner to enter and inspect any premises used for or in connection with such work for the purpose of ascertaining whether the provisions of this Order have been or are being complied with.
- 5. Any person who contravenes or fails to comply with any of the provisions of this Order shall be liable to the penalties prescribed by Defence Regulation 94 of the Defence Regulations (as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946).

6. This Order shall come into operation on its publication in the Gazette.
