No. 736. THE CUSTOMS MANAGEMENT LAW, 1954.

FORM OF BONDS, DOCUMENTS AND FORMS.

In exercise of the powers vested in me by section 239 of the Customs Management Law, 1954, I hereby prescribe that the forms necessary for 8 of 1954 carrying out the provisions of the Customs Laws shall be as set out in the Schedule hereto.

- 1. All forms specified in Part I of the Schedule shall be printed in the English language. Specimens of such forms may be obtained from the Office of the Comptroller, Famagusta.
- 2. All forms specified in Part II of the Schedule will be supplied by the Comptroller to such persons as need them for the transaction of their business with the Customs.

- (i) C. 1. Inward Manifest, to be printed in black on white paper.

 Short size: 17"×7".

 Long size: 17"×13½".
- (ii) C.21 Entry for warehousing, to be printed in black on white paper, $17'' \times 12\frac{1}{2}''$.
- (iii) C.22. Transhipment Entry or Export Entry from Bonded Warehouse, to be printed in black on white paper, $18\frac{1}{2}$ " × $12\frac{1}{2}$ ".
- (iv) C. 23. Entry ex Warehouse for goods for home consumption, to be printed in black on white paper, $18\frac{1}{2}" \times 12\frac{1}{2}"$.
- (v) C.30. Entry for goods ex Ship or Aircraft for home consumption, to be printed in black on white paper, $18\frac{1}{2}'' \times 12\frac{1}{2}''$.
- (vi) C.32. Export Entry (General) to be printed in black on white paper, 17"×12½".
- (vii) C.32B. Export Entry for Drawback goods, to be printed in red on white paper, $17'' \times 13\frac{1}{2}''$.
- (viii) C.45. Outward Manifest, to be printed in black on white paper, 17"×7".
