BYE-LAWS MADE BY THE IMPROVEMENT BOARD OF POLEMI.

In exercise of the powers vested in them by section 24 of the Villages (Administration and Improvement) Laws, 1950 and 1953, the Improvement Board of Polemi hereby make the following bye-laws:—

1. These bye-laws may be cited as the Villages (Administration and Improvement) Polemi Bye-laws, 1955, and shall be read as one with the Villages (Administration and Improvement) Polemi Bye-laws, 1952 (hereby referred

to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Villages (Administration and Improvement) Polemi Bye-laws, 1952 and 1955.

2. Bye-law 26 of the principal Bye-laws is hereby amended by the deletion from sub-paragraphs (a), (b), (c), (d), (e), (f) and (g) thereof of the fees 1/-, 2/-, 1/-, -/6, -/3, -/6 and 1/- and by the substitution therefor of the fees 2/-, 3/-, 1/6, 1/-, -/6, 1/- and 1/6 respectively :

Provided that when any animal which has been slaughtered is to be used exclusively by the owner and his family for the purpose of salting, two shillings shall, irrespective of the weight of the animal, be paid in lieu of the fees hereinbefore prescribed.

3. Bye-law 75 (1) of the principal Bye-laws is hereby amended by the deletion from sub-paragraphs (b), (c), (d), (e) and (f) thereof of the fees -/2, -/1, -/1, -/1 and -/2 and by the substitution therefor of the fees 1/-, -/5, -/3, -/3 and -/4 respectively.

4. Bye-law 82 of the principal Bye-laws is hereby amended by the deletion from sub-paragraph (c) thereof of the fee -/3 and by the substitution therefor of the fee 1/-.

5. Bye-law 185 (1) of the principal Bye-laws is hereby amended by the deletion from sub-paragraphs (a), (b), (c), (d), (e), (g) and (h) thereof of the fees 10/-, 10/-, 10/-, 10/-, 10/-, 20/- and 10/- and by the substitution therefor of the fees 20/-, 20/-, 20/-, 20/-, 20/-, 40/- and 60/- respectively.

6. The Second Appendix to the Polemi Bye-laws published in Supplement No. 3 to the *Cyprus Gazette* of 1952 under Notification No. 279 is hereby amended by the deletion therefrom of bye-laws 180, 181, 182, 183 and 184.

The above bye-laws have been approved by the Colonial Secretary.
