

DIRECTION BY THE GOVERNOR UNDER SECTION 29 (2).

Whereas certain offices in the Evcaf Department have been declared pensionable :

Now, therefore, in exercise of the powers vested in him by sub-section (2) of section 29 of the Evcaf Law (Cap. 259), His Excellency the Governor has been pleased to direct that the following provisions of the Pensions Law (Cap. 288 and Law 4 of 1952) shall apply, *mutatis mutandis*, to the grant of any pension and gratuity attached to any office declared pensionable as aforesaid :

Provided that in the construction thereof, unless the context otherwise requires, the following expressions therein shall be deemed to have the meanings hereby assigned to them :—

“funds of Cyprus” means funds of the Evcaf Department ;

“other public service” means public service under the Government ;

“pensionable emoluments”—

(a) in respect of service in the Evcaf Department includes salary and personal allowance but does not include duty allowance or any other emoluments whatsoever ;

(b) in respect of other public service means emoluments which count for pension in accordance with the Law or Regulations in force in such service ;

“pensionable office” means—

(a) in respect of service in the Evcaf Department an office which has been declared by the Governor, with the sanction of the Secretary of State, by a notification published in the *Gazette*, to be pensionable :

Provided that any office declared to be pensionable may be declared by the Governor with the sanction of the Secretary of State by notification published in the *Gazette*, to be no longer pensionable, due regard being had to existing rights ;

(b) in respect of other public service an office which is a pensionable office under the Law or Regulations in force in such service ;

“personal allowance” means a special addition to such salary granted personally to the holder for the time being of the office but does not include such an addition if it is granted subject to the condition that it shall not be pensionable ;

“public service” means service in a civil capacity in the Evcaf Department or under the Government ;

“salary” means the salary attached to a pensionable office ;

“service of Cyprus” means service in the Evcaf Department.
