## THE LAND ACQUISITION LAW. CAP. 233 AND LAW 26 OF 1952.

NOTIFICATION UNDER SECTION 7.

R: P., ARMITAGE,

Governor.

Whereas by Notification published under No. 530 in Supplement No. 3 to the Gazette of the 26th August, 1954, the Governor declared the erection of the New Paphos Hospital and the acquisition of certain lands mentioned in the aforesaid Notification, to be an undertaking of public utility ;

And whereas the Commissioner, Paphos, by notice published under No. 651 in Supplement No. 3 to the Gazette of the 11th November, 1954, gave particulars of the properties required in connection with the aforesaid undertaking ;

And whereas the Commissioner forwarded to the Governor the required recommendations, plan and particulars, together with the objections made;

And whereas I, the Governor, have approved the plan and particulars submitted and have considered it expedient, having regard to all the circumstances of the case, that the properties in question be acquired :

Now, therefore, in exercise of the powers yested in me by section 7 of the Land Acquisition Law, I, the Governor, do hereby sanction the acquisition Cap. 233. under the provisions of the said, Law of the properties particulars whereof 26 of 1952. are specifically set out in the notice of the Commissioner, Paphos, hereinbefore mentioned.

THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.

Order made by the Governor under Defence Regulation 79B.

In exercise of the powers vested in him by Defence Regulation 79B, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force under the Supplies Gazette :

and Services (Continuance) Order, 1954, His Excellency the Governor has Supplement been pleased to make the following Order :-

No. 2A: 9.12.1954.

1. This Order may be cited as the Trade Dispute (Electricity Authority) (Tribunal) Order, 1955.

2. In this Order, unless the context otherwise requires-

"trade dispute" means the existing trade dispute between the Electricity Authority of Cyprus and its servants or employees in connection with the terms and conditions of the employment and the amount of wages payable ;

"tribunal" means the tribunal established under this Order,

3. It is hereby established a tribunal for the settlement of the trade dispute consisting of :---

(a) Dr. Colin Raeburn, C.B.E., Chairman.

(b) John Eliades, Advocate of Limassol

(c) Andreas Pouyouros, Advocate of Famagusta } Members. 4.--(1) The tribunal shall inquire into the trade dispute and make its award without delay :

Provided that in case of disagreement the majority's award shall be the award of the tribunal:

Provided further that if none of the members agree, the opinion of the Chairman shall prevail.

(2) The award shall be submitted to the Governor who shall as soon as possible cause the same to be published in the Gazette and thereupon such award shall be binding on all parties.

5.-(1) Save as is otherwise provided in this clause the tribunal shall regulate its own procedure and shall not be bound by the rules of evidence in civil or criminal cases.

(2) The sittings of the tribunal shall be private and no representatives of the press shall be allowed to attend the proceedings.

(3) The tribunal shall permit any interested person to appear in any proceedings before it through an advocate.

PERMIT UNDER SECTION 8.

Whereas in pursuance of the provisions of the Missionary Educational and Medical (Alien Regulation) Law, the person whose name appears in the Schedule hereto has applied for a permit under the provisions of the said Law;

And whereas the said person has given an undertaking in writing to pay all due obedience and respect to the Government of Cyprus, and while carefully abstaining from participation in political affairs, that he desires and purposes ex animo to work in friendly co-operation with the said Government in all matters in which his influence might properly be exerted ; and, in particular, he has undertaken that, if engaged in educational work, his influence will be exerted to promote loyalty to the Government of Cyprus in the minds of his pupils and to make them good citizens of the British Empire:

Now, therefore, in exercise of the powers vested in him by section 8 of the Missionary Educational and Medical (Alien Regulation) Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to grant to the person whose name appears in the first column of the Schedule hereto a permit to commence and carry on the work set down in the second column of the said Schedule.
