## ORDER UNDER SECTION 15.

Whereas in pursuance of Notification No. 416 published in Supplement No. 3 to the *Gazette* of the 27th August, 1953, a fit and proper site has been registered in the books of the Land Registry Office as a burial ground for the burial of the dead by the Greek-Orthodox community of Pyrga village in the District of Famagusta :

Now, therefore, in exercise of the powers vested in the Governor by section 15 of the Burials Law, and duly delegated to me under Notification No. 172, published in Supplement No. 3 to the *Gazette* of the 19th June, 1947, I do hereby order that from and after the 9th April, 1955, no burial shall take place in the burial ground in lieu whereof the new burial ground above referred to has been provided.

## THE MINES AND QUARRIES (REGULATION) LAW, 1953.

## DELEGATION OF POWER TO GRANT PROSPECTING PERMITS UNDER SECTION 11 AND OF POWERS CONNECTED THEREWITH.

In exercise of the powers vested in him by section 11 of the Mines and Quarries (Regulation) Law, 1953, and of every other power enabling him in that behalf, His Excellency the Governor has been pleased to delegate to the Inspector of Mines the power to grant prospecting permits under section 11 of the said Law and all powers connected therewith and vested in the Governor under the said Law. 14 of 1953.
