In exercise of the powers vested in him by the Supplies and Services (Transitional Powers) Act, 1945, as extended to the Colony by the Supplies and Services (Transitional Powers) (Colonies, etc.) Order in Council, 1946, which continues in force under the Supplies and Services (Continuance) Order, 1954, His Excellency the Governor has been pleased to order as follows :—

1. These Regulations may be cited as the Defence (Exportation of Goods) (Amendment) Regulations, 1955, and shall be read as one with the Defence (Exportation of Goods) Regulations, 1943 to 1954 (hereinafter referred to as "the principal Regulations") and the principal Regulations and these Regulations may together be cited as the Defence (Exportation of Goods) Regulations, 1943 to 1955.

2. Regulation 3 of the principal Regulations (as contained in regulation 3 of the Defence (Exportation of Goods) (Amendment) Regulations, 1950) is hereby amended by the insertion therein, immediately after paragraph (b), of the following paragraph :—

"(c) goods produced or manufactured in the Colony which are to be exported to any destination, where the f.o.b. value of the consignment of such goods does not exceed £25."
