In exercise of the powers vested in him by clause 5 (2) of the Trading with the Enemy (Custodian) Orders, 1940 to 1946, and by clause 18 (3) of the Distribution of German Enemy Property Order, 1953, His Excellency the Governor has been pleased to direct that wherever a request has been duly made by a former owner or his successor in title in accordance with the terms of the official notices appearing in Supplement No. 1 to the *Gazettes* Nos. 3708 and 3742 of 30th July, 1953 and 11th February, 1954, in respect of a former German-owned registered trade mark, vested in the Custodian of Enemy Property, and where such request has been advertised in accordance with the terms of the said Notices and no objection to the re-assignment of the mark has been lodged, and where the Custodian is satisfied that the request is valid, the Custodian shall re-assign such trade mark to the party making the request.
