No. 365. THE DEFENCE (IMPORTATION OF GOODS) REGULATIONS, 1943 TO 1954.

OPEN GENERAL IMPORT LICENCES No. 8800, 8861 AND 8862.

In exercise of the powers vested in me by virtue of the Defence (Importation of Goods) Regulations, 1943 to 1954, I hereby grant to any importer registered under the provisions of the Defence (Registration of Importers and Resellers) Order 1954, an Open General Import Licence under No. 8800 to import into the Colony in any quantity any goods originating in the United Kingdom or any other British Colony if such goods are imported into the Colony either directly from their countries of origin or through the United Kingdom or any other British Colony:

Provided that no goods enumerated in the Schedule hereto or originating or supplied

from any other territories shall be imported under this licence:

Provided further that in all cases covered by this licence payment shall be made in

sterling.

2. I further hereby grant to any person an Open General Licence under No. 8861 to import into the Colony goods originating in the United Kingdom or any other British Colony not exceeding a value of £25 in any one consignment:

Provided that such goods are shown to the satisfaction of the Comptroller of Customs and Excise or his authorised representative to be imported solely for the private use of

such person and not for re-sale:

Provided further that no goods enumerated in the Schedule hereto or originating or

supplied from any other territories shall be imported under this licence.

3. I further hereby grant to any person an Open General Licence under No. 8862 to import into the Colony one motor passenger car or motor cycle, whether used or not, originating in the United Kingdom, provided that such motor passenger car or motor cycle is shown to the satisfaction of the Comptroller of Customs and Excise or his authorised representative to be imported for the private use of such person.

4. The above Open General Import Licences are deemed to be written licences issued by me under Regulation 2 (1) (a) of the Defence (Importation of Goods) Regulations, 1943 to 1954, and are subject to the provisions of Regulation 2 (1) (b) of the said

Regulations.

5. The Open General Import Licence No. 62000 published under Notification No. 680 in Supplement No. 3 to the *Gazette* of 31st December, 1953, is hereby cancelled without prejudice to anything done or left undone thereunder.

SCHEDULE.

The Divisions, Groups and Items set out in the second column of this Schedule refer to the Divisions, Groups and Items, respectively, which are set out in the Standard International Trade Classification, published in United Nations Statistical Papers Series M.
