**No. 379.****THE IRRIGATION (PRIVATE WATER) ASSOCIATION LAWS,  
1949 AND 1954.**

In pursuance of the provisions of sub-section (3) of section 12 of the Irrigation (Private Water) Association Laws, 1949 and 1954, the following rules made by the Committee of the Irrigation Association of Bellapais ("Vasiliki" water), in the District of Kyrenia, are published in the *Gazette*.

IRRIGATION ASSOCIATION OF BELLAPAIS ("VASILIKI" WATER).  
*Rules.*

1. These rules may be cited as the Irrigation Association of Bellapais ("Vasiliki" water) Rules, 1955, and shall be read as one with the Irrigation Association of Bellapais ("Vasiliki" water) Rules, 1950 (hereinafter referred to as "the principal Rules") and the principal Rules and these rules may together be cited as the Irrigation Association of Bellapais ("Vasiliki" water) Rules, 1950 and 1955.

2. Rule 7 of the principal Rules is hereby amended by the deletion therefrom of the words "ten shillings" and the substitution therefor of the words "twenty shillings".
