## Bye-laws made by the Improvement Board of Panayia.

In exercise of the powers vested in them by section 24 of the Villages (Administration and Improvement) Laws, 1950 and 1953, the Improvement Board of Panayia hereby make the following bye-laws :--

These bye-laws may be cited as the Villages (Administration and Improvement) Panayia (Amendment) Bye-laws, 1955, and shall be read as one with the Villages (Administration and Improvement) Panayia Bye-laws, 1951 and 1954 (hereinafter referred to as "the principal bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Villages (Administration and Improvement) Panayia Bye-laws, 1951 to 1955.

2. Bye-law 81 (1) of the principal Bye-laws is hereby amended by the deletion therefrom of the words "two to forty shillings" after the words "shall be from" and by the substitution therefor of the words "five to one hundred shillings".

Bye-law 139 (3) of the principal Bye-laws is hereby amended by the deletion therefrom of the words "three shillings per year or part thereof" after the words "shall be" and by the substitution therefor of the words "from one to three shillings per year or part thereof, to be determined in each case by the Inspector".

4. Items 19, 55 and 56 of the Second Schedule to the principal Bye-laws are hereby amended by the deletion therefrom of the figures 5 paras, 10 paras and 10 paras under the column "fees for any quantity in excess of the minimum weight. Paras per oke or part thereof" and by the substitution therefor of the figures 3 paras, 5 paras and 5 paras respectively.

The above bye-laws have been approved by the Colonial Secretary.
