THE SHEEP AND GOATS (SHEPHERDS' LICENSING AND CONTROL) LAW.

CAP. 157.

NOTICE UNDER SECTION 12.

In exercise of the powers vested in me by section 12 of the Sheep and Goats (Shepherds' Licensing and Control) Law, I hereby direct that during the period between the 1st August and 15th October, 1955, flocks within the village areas of Mesakhorio in the District of Paphos, shall, between the hours of sunset and sunrise, be kept inside an enclosure and not taken outside an enclosure :

Provided that nothing in this notice contained shall prevent the driving of any flock, under the proper charge of a licensed shepherd, from one village area to another, along any public road, at any hour.

No. 451. THE GRAIN CONTROL LAWS, 1953 AND 1954.

REGULATIONS MADE BY THE GRAIN COMMISSION UNDER SECTION 20.

7 of 1953
45 of 1954.

In exercise of the powers vested in it by section 20 of the Grain Control Laws, 1953 and 1954, the Commission hereby makes the following Regulations :—

1. These Regulations may be cited as the Grain Control (Milling and Bakeries) (Amendment) Regulations, 1955, and shall be read as one with the Grain Control (Milling and Bakeries) Regulations, 1954 (hereinafter referred to as "the principal Regulations") and the principal Regulations and these Regulations may together be cited as the Grain Control (Milling and Bakeries) Regulations, 1954 and 1955.

2. Schedule 1 to the principal Regulations is hereby deleted and the following Schedule substituted therefor :—

3. Schedule 3 to the principal Regulations is hereby deleted and the following Schedule substituted therefor :—

" SCHEDULE 3.—(Regulation 13.)

Bread sold or purchased in any town.	Bread sold or purchased in any village.
(a) thirty-three (33) mils for each loaf of one kilogram.	(a) thirty-six (36) mils for each loaf of one kilogram.
(b) seventeen (17) mils for each loaf of one-half kilogram.	(b) eighteen (18) mils for each loaf of one-half kilogram.

4. These Regulations shall come into force on the 1st day of August, 1955.

The above Regulations have been approved by His Excellency the Governor.
