No. 454.**THE HOTELS, LODGING HOUSES AND PUBLIC BUILDINGS
(REGULATION) LAW.**

CAP. 105.

BYE-LAWS MADE BY THE MUNICIPAL COUNCIL OF LEFKONIKO UNDER SECTION 4.

Cap. 105.

Whereas by Order-in-Council No. 2602 published under Notification No. 125 in Supplement No. 3 to the *Gazette* of the 12th March, 1953, the Hotels, Lodging Houses and Public Buildings (Regulation) Law has been applied to hotels, lodging houses and public buildings situated within the limits of all municipal corporations.

Now, therefore, in exercise of the powers vested in them, the Municipal Council of the Municipal Corporation of Lefkoniko hereby make the following bye-laws :—

1. These bye-laws may be cited as the Hotels, Lodging Houses and Public Buildings (Lefkoniko) Bye-laws, 1955, and shall come into operation on the 1st day of August, 1955.

2.—(1) Subject to the provisions of paragraph (2) of this bye-law, the Hotels, Lodging Houses and Public Buildings (Nicosia) Bye-laws, 1955, published in Supplement No. 3 to the *Gazette* of the 28th April, 1955 (hereinafter referred to as "the Model Bye-laws"), shall—

(a) be deemed to be bye-laws made by the Municipal Council of the Municipal Corporation of Lefkoniko and to be incorporated herein, and

(b) apply to the hotels, lodging houses and public buildings within the municipal limits of the Municipal Corporation of Lefkoniko.

(2) The Schedules set out in the First Appendix hereto shall be substituted for the corresponding Schedules of the Model Bye-laws.
