Bye-laws made by the Municipal Council of Famagusta UNDER SECTION 4.

Whereas by Order-in-Council No. 2602 published under Notification No. 125 in Supplement No. 3 to the Gazette of the 12th March, 1953, the Hotels, Lodging Houses and Public Buildings (Regulation) Law has been applied to hotels, lodging houses and public buildings situated within the limits of all Municipal Corporations:

Now, therefore, in exercise of the powers vested in them, the Municipal Council of the Municipal Corporation of Famagusta hereby make the following bye-laws :---

- 1. These bye-laws may be cited as the Hotels, Lodging Houses and Public Buildings (Famagusta) Bye-laws, 1955, and shall come into operation upon their publication in the Gazette.
- 2.—(1) Subject to the provisions of paragraph (2) of this bye-law, the Hotels, Lodging Houses and Public Buildings (Nicosia) Bye-laws, 1955, published in Supplement No. 3 to the Gazette of the 28th April, 1955 (hereinafter referred to as "the model bye-laws"), shall—

 (a) be deemed to be bye-laws made by the Municipal Council of the

Municipal Corporation of Famagusta and to be incorporated herein, and

(b) apply to the hotels, lodging houses and public buildings within the Municipal limits of the Municipal Corporation of Famagusta:

Provided that for the word "Nicosia" wherever it occurs in the model

bye-laws the word "Famagusta" shall be substituted.

(2) The bye-law set out in the first Appendix hereto shall be substituted for the corresponding bye-law of the model bye-laws.

FIRST APPENDIX.

(Bye-law 20.)

It shall be the duty of the owner or person in charge of any hotel or public building to cause all food and all articles intended, exposed or offered for food or sale for human consumption to be protected from flies and other insects, dust and vermin by keeping them in well closed clean receptacles and to be handled by clean hands and by persons in possession of a valid certificate of health issued under Bye-laws 74 to 79 (both inclusive) of the Famagusta Municipal Bye-laws, 1940 to 1955, or any bye-laws amending or substituted for the same.

Now, therefore, in exercise of the powers vested in them, the Municipal Council of the Municipal Corporation of Larnaca hereby make the following bye-laws:—

- 1. These bye-laws may be cited as the Hotels, Lodging Houses and Public Buildings (Larnaca) Bye-laws, 1955, and shall come into operation upon their publication in the Gazette.
- 2.—(1) Subject to the provisions of paragraph (2) of this bye-law, the Hotels, Lodging Houses and Public Buildings (Nicosia) Bye-laws, 1955, published in Supplement No. 3 to the Gazette of the 28th April, 1955 (hereinafter referred to as "the model bye-laws"), shall—
 - (a) be deemed to be bye-laws made by the Municipal Council of the Municipal Corporation of Larnaca and to be incorporated herein,
 - (b) apply to the hotels, lodging houses and public buildings within the municipal limits of the Municipal Corporation of Larnaca:

Provided that for the word "Nicosia" wherever it occurs in the model bye-laws the word "Larnaca" shall be substituted.

(2) The bye-law set out in the First Appendix hereto shall be substituted for the corresponding bye-law of the model bye-laws.

FIRST APPENDIX. (Bye-law 20).

It shall be the duty of the owner or person in charge of any hotel or public building to cause all food and all articles intended, exposed or offered for food or sale for human consumption to be protected from flies and other insects, dust and vermin by keeping them in well closed clean receptacles and to be handled by clean hands and by persons in possession of a valid certificate of health issued under Bye-laws 78 to 93 (both inclusive) of the Larnaca Municipal Bye-laws, 1949 to 1955, or any bye-laws amending or substituted for the same.

The above Bye-laws have been approved by His Excellency the Governor. (M.P. 1088/55.)

The following rules made by the Village Health Commission of Katokopia, in the District of Nicosia, and approved by the Commissioner are published in the Gazette.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF KATOKOPIA UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, Cap. 142, the Village Health Commission of Katokopia hereby make the following rules:-

These rules may be cited as the Village Health (Katokopia) Gazette: (Amendment) Rules, 1955, and shall be read as one with the Village Health Supplement (Katokopia) Rules, 1938 (hereinafter referred to as "the principal Rules"), No. 3A: and the principal Rules and these rules may together be cited as the Village 19.8.1938 Health (Katokopia) Rules, 1938 and 1955.
