THE FOREST LAW. CAP. 93.

ORDER IN COUNCIL No. 2779 MADE UNDER SECTION 3 (2).

In exercise of the powers vested in him by section 3 (2) of the Forest Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :---

This Order may be cited as the Minor State Forests (Famagusta) (Amendment) Order, 1955, and shall be read as one with the Minor State Forests (Famagusta) Orders, 1943 to 1951 (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Minor State Forests (Famagusta) Orders, 1943 to 1955.

2. The Schedule to the principal Order is hereby amended by the addition thereto immediately after the area No. 37 (relating to the area of Ayios Yeoryios) of the following area :---

"38. Sinda in Famagusta District.

(i) A portion of the crown land under plot No. 87.31 of Sheet XXXII, Plan No. 3, at the locality 'Temeller', demarcated by boundary stones numbered consecutively from 1-21, inclusive, comprising 72 donums, 2 evleks and 200 sq. feet or thereabouts and shown on the Government Survey Plan Serial No. 1592, delineated thereon in green and marked 'A'.

(ii) A portion of the crown land under plot No. 87.32 of Sheet XXXII, Plan No. 3, at the locality 'Temeller', demarcated by boundary stones numbered consecutively from 1-20 inclusive, comprising 34 donums, 3 evleks and 2,100 sq. ft. or thereabouts and shown on the Government Survey Plan Serial No. 1592, delineated thereon in green and marked 'B'.

No. 492. THE PUBLIC RIVERS PROTECTION LAW. CAP. 143.

NOTIFICATION.

1. Whereas the portion of the Public River Yialias, in the villages of Tymbou and Margo, in the District of Nicosia, commencing at a line joining the south-western corner of plot No. 108 of Block J, Tymbou village, to the most eastern point of plot No. 28 of Block D, Margo village, and proceeding downstream for a distance of 3 miles or thereabouts, and ending at a line joining the north-eastern corner of plot No. 1 of Block G, Tymbou village, to the south-eastern corner of plot No. 37 of Block F, Tymbou village, more particularly defined as the area coloured red on the Government Survey Plan, Serial No. 1633, filed in M.P. (D.I.N.) 64/51 in the Office of the Commissioner, Nicosia, has been declared by the Yialias River (Protection) Order, 1955, to be a river for the purposes of the Public Rivers Protection Law;

Notice is hereby given that from the date hereof—

- (a) the removal or carrying away of shingle, gravel, sand, soil or other substance from the bed, bank or wall of the portion of the river aforesaid;
- (b) the dumping of any rubble, rubbish, sweepings or other refuse in the bed or upon any bank or wall of the portion of the river aforesaid;

is prohibited.

2. The attention of the public is drawn to the provisions of the Public Rivers Protection Law, under which any person acting in contravention of a notification issued thereunder, is liable to imprisonment not exceeding one month or to a fine not exceeding five pounds.
