#### THE MUNICIPAL CORPORATIONS LAW. No. 533.

## CAP. 252 AND LAWS 11 OF 1950, 31 OF 1951, 20 OF 1953, 29 OF 1954, 57 OF 1954 AND 14 OF 1955.

### BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF NICOSIA.

In exercise of the powers vested in them by the Municipal Corporations Law, and otherwise, the Council of the Municipal Corporation of Nicosia, hereby make the following bye-laws :-

Gazette : 1. These bye-laws may be cited as the Nicosia Municipal (Amendment No. 2) Bye-laws, 1955, and shall be read as one with the Nicosia Municipal Bye-laws, 1938 to 1955 (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Nicosia Municipal Bye-laws, 1938 to (No. 2) 1955.

2. Paragraph (1) of bye-law 25 of the principal Bye-laws (as set out in Gazette : bye-law 3 of the Nicosia Municipal (Amendment) Bye-laws, 1947) is hereby amended by the insertion immediately after the words "Meat Market" of the words " or a Pork and Meat Market ".

3. Chapter 5 (containing bye-laws 27 to 31, as set out in bye-law 3 of the Gazette : Nicosia Municipal (Amendment) Bye-laws, 1947) is hereby cancelled and the following substituted therefor :-

# " CHAPTER 5.—Pork and Meat Market.

27. The shops, stalls, and places designated by the Council within each Municipal Market as Pork and Meat Markets and bearing the inscription 'Pork and Meat Market' are hereby established as Pork and Meat Markets.

28. The Pork and Meat Markets shall be under the control of an inspector appointed by the Council.

29. The inspector shall keep the Pork and Meat Markets open daily from sunrise till such time (not being later than sunset) as there is fresh pork and meat on sale therein, and may allow it to be open at such other hours as the inspector, subject to the Mayor's directions, may think fit.

30. No person shall sell the carcass of any pig or any fresh pork or fresh meat except at a Pork and Meat Market.

31.-(1) Any fresh pork or fresh meat sold outside a Pork and Meat Market may be seized by the inspector or any other person authorized in writing by the Mayor and destroyed or otherwise disposed of as the Mayor may direct in writing.

(2) For the purpose of this bye-law and bye-law 30, any person whose ordinary occupation is to sell pork or meat shall be deemed to sell any pork or meat found in his possession until he proves the contrary.

31A. Nothing in this Chapter contained shall apply to any person selling fresh meat and pork outside a Pork and Meat Market in premises specially approved by the Council."

4. The principal Bye-laws are hereby amended by the insertion therein, immediately after bye-law 40 of the following Chapter and bye-law :---

# "Chapter 6A.—Open Air Markets for PerishableGoods.

40A.—(1) The Council may from time to time by public notification fix places for the purpose of holding at least once a week Open Air Markets for Perishable Goods.

(2) The Open Air Markets for Perishable Goods shall be under the control of an inspector appointed by the Mayor in writing.

(3) The place or places where and the manner in which perishable goods are to be sold in the Open Air Markets for Perishable Goods shall be appointed and regulated by the inspector,

(4) The fees prescribed by bye-law 14 shall be paid to the inspector by the owner or the person in charge of perishable goods brought into or on sale in the Open Air Markets for Perishable Goods.

(5) Any perishable goods sold in contravention of this bye-law may be seized by the inspector or any other person authorized in writing by the Mayor, and disposed of as the Mayor may direct.

(6) The inspector or any other person authorized in writing by the Mayor, may at any time enter any places believed by him to contain perishable goods in contravention of this bye-law.".

5. Bye-law 124A of the principal Bye-laws (as set out in bye-law 2 of the Nicosia Municipal (Amendment) Bye-laws, 1953) is hereby amended as follows :-

(a) by the insertion in paragraph (1), immediately after sub-paragraph (b)(the colon at the end thereof being substituted by a semi-colon)

of the following sub-paragraph :---

"(c) cook or engage in cooking or cause to be cooked any food in any place other than a place of public resort within a distance of 100 feet from any street, when such food is sold or exposed for sale or intended to be sold to the public."; (b) by the cancellation of the proviso to paragraph (1) thereof.
