BYE-LAWS MADE BY THE IMPROVEMENT BOARD OF PEYIA.

In exercise of the powers vested in them by section 20 of the Villages (Administration and Improvement) Laws, 1950 and 1953, the Improvement Board of Peyia hereby make the following bye-laws :—

1. These bye-laws may be cited as the Villages (Administration and Improvement) Peyia Bye-laws, 1955, and shall be read as one with the Villages (Administration and Improvement) Peyia Bye-laws, 1951 (hereby

referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Villages (Administration and Improvement) Peyia Bye-laws, 1951 and 1955.

2. Bye-law 26 of the principal Bye-laws is hereby amended by the deletion from sub-paragraphs (a), (b), (c), (d), (e), (f), (g) and (h) thereof of the fees 1/-, 2/-, -/6, -/4, -/4, -/6, 1/- and 1/3 and by the substitution thereof of the fees 2/-, 4/-, 1/3, -/8, -/8, 1/3, 2/- and 2/6 respectively together with the following proviso at the end of paragraph (h) thereof:

Provided that when any animal which has been slaughtered is to be used exclusively by the owner and his family for the purpose of salting, 2 shillings shall, irrespective of the weight of the animal, be paid in lieu of the fees hereinbefore prescribed.

3. Bye-law 51 (1) of the principal Bye-laws is hereby amended by the deletion from sub-paragraphs (a), (b), (c), (d) and (e) thereof of the fees -/6, -/4, 1/-, 2/- and 3/- and by the substitution therefor of the fees 1/3, -/8, 2/-, 4/- and 6/- respectively.

4. Bye-law 58 (1) of the principal Bye-laws is hereby amended by the deletion from sub-paragraphs (a), (b) and (c) thereof of the fees 1/-, 2/- and 3/- and by the substitution therefor of the fees 2/-, 4/- and 6/- respectively.

5. Bye-law 75 (1) of the principal Bye-laws is hereby amended by the deletion from sub-paragraphs (a), (b), (c), (d), (e), (f), (g) and (h) thereof of the fees 2/-, 1/-, 2/-, -/4, -/3, -/1, -/1 and -/2 and by the substitution therefor of the fees 3/-, 2/-, 3/-, -/6, -/6, -/3, -/3 and -/4 respectively.

The above bye-laws have been approved by the Colonial Secretary.

## No. 55. THE PUBLIC HEALTH (VILLAGES) LAW.

CAP. 142.

### RULES MADE BY THE VILLAGE HEALTH COMMISSION OF DHROMOLAXIA IN THE DISTRICT OF LARNACA UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, the Village Health Commission of Dhromolaxia hereby make the following rules:—

1. These rules may be cited as the Village Health (Dhromolaxia) Rules, 1955, and shall come into operation on their publication in the *Gazette*.

2.—(1) Subject to the provisions of paragraphs (2) and (3) of this rule, the Village Health (Nikos) Rules, 1952, published in Supplement No. 3 to the *Gazette* of the 19th November, 1952, shall—

(a) be deemed to be rules made by the Village Health Commission of Dhromolaxia and to be incorporated herein; and

(b) apply to the village of Dhromolaxia: Provided that for the word "Nikos" and for the word "Nicosia" whenever they occur in the model Rules, the word "Dhromolaxia" and the word "Larnaca" shall be substituted respectively.

(2) The rules set out in Part I of the Schedule hereto shall be substituted for the corresponding rules of the Village Health (Nikos) Rules, 1952.

(3) Those rules of the Village Health (Nikos) Rules, 1952, mentioned in Part II of the Schedule hereto, shall not apply to the village of Dhromolaxia.
