This Order may be cited as the Minor State Forests (Larnaca group) Amendment Order, 1955, and shall be read as one with the Minor State Forests (Larnaca group) Order, 1952 (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Minor State Forests (Larnaca group) Orders, 1952 and 1955.

2. The Schedule to the principal Order is hereby amended by the addition thereto of that area relating to the Village of Athienou in Larnaca District as follows :—

2. Athienou in the District of Larnaca.

A portion of the Crown land under plots 168, 169, 171/1, 254 and 281 of sheet XXXI, Plan Nos. 21, 22 and 30, at the locality "Merikoudhia" demarcated by boundary stones numbered consecutively from 1 to 20, inclusive, comprising 68 donums, 1 evlek and 1,200 sq. feet approximately and shown on the Government Survey Plan Serial No. 1621, delineated thereon in green.

In exercise of the powers vested in him by sections 7 and 8 of the Customs Management Law, 1954, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :—

2. This Order may be cited as the Customs Management (Ports, Aerodromes and Shipping Places) (Amendment) Order, 1955, and shall be read as one with the Customs Management (Ports, Aerodromes and Shipping Places) Order, 1954 (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Customs Management (Ports, Aerodromes and Shipping Places) Order, 1954 and 1955.

3. Paragraph 4 of the principal Order is hereby amended by the substitution for the words "Dhekelia and Latchi" (line 2) of the words "Dhekelia, Latchi and Moni",

4. Part II of the Schedule to the principal Order is hereby amended by the addition at the end thereof, in their respective columns, of the following place and particulars :—

**THE VILLAGES (ADMINISTRATION AND IMPROVEMENT)
LAWS, 1950 AND 1953.**

ORDER MADE UNDER SECTION 22 (a) (i).

Authority to the Improvement Board of Peyia to contract a loan.

In exercise of the powers vested in me by section 22 (a) (i) of the Villages (Administration and Improvement) Laws, 1950 and 1953, I, the Colonial Secretary, do hereby order as follows :—

1. The Improvement Board of Peyia (hereinafter referred to as “the Board”) shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as “the Lenders”) a sum not exceeding one thousand pounds (£1,000) at a rate of interest not exceeding four per centum (4%) per annum, subject to the following terms and conditions, that is to say :—

(a) the sum borrowed shall be repayable by the Board to the Lenders in ten equal annual instalments (comprising sinking fund and interest);

(b) the sum borrowed shall be utilized by the Board for the improvement of the village water supply.

2. For the purpose of securing the repayment of the sum under the loan, the Board shall, subject to any prior mortgage thereon, mortgage to the Lenders all the rates, fees, rents, tolls or charges now payable or hereafter to become payable to the Board.
