No. 583. THE SOIL CONSERVATION LAW, 1952.

NOTICE UNDER SECTION 9.

Pursuant to section 9 of the Soil Conservation Law, 1952, it is hereby notified that, with the approval of the Governor, a Soil Conservation Division has been formed in respect of the area lying within the following boundaries that is to say :—

The boundary commences at a point 30 yards approximately east of north-western corner of plot No. 115 of the Government Survey Plan No. VII.63, locality "Platides", which point is on the northern boundary of the said plot and proceeds north-eastwards and south-eastwards along the boundaries of and including the said plot (part), plots Nos. 114, 113, 112, 110, 107, 63 (part), 98, 96, 95, 94, 93, 92, 91 (part) and 90 of the said plan, locality "Potami", to the north-eastern corner of the last mentioned plot, which corner is on a road leading from the village of Ayios Efstathios to the village of Ayios Theodoros; thence southwards along the said road to the south-eastern corner of plot No. 265 of the said plan; thence in an easterly direction along the boundaries of and including plots Nos. 220 (part), 267, 268 (part), 269 (part), 271, 272 (part) and 273 of the said plan; plots Nos. 112 (part), 167, 171, 164 (part) and 163 (part) of the Government Survey Plan No. VII.64, locality "Gadolakos", to a point 50 yards approximately north-east of the most southern point of the last mentioned plot, which point is on a road leading from the village of Vokolidha to the village of Ayios Theodoros; thence south-westwards along the said road to its junction with a track coming from Dianoulia locality; thence eastwards along the said track to the north-eastern corner of plot No. 172, of the said plan; thence in a south-easterly direction along the boundaries of and including the said plot, plots Nos. 209, 207 (part), 206 (part), 205 (part), 204, 226, 253 (part), 252, 251 (part), 249 (part), 248, 253, 247, 246, 288, 289 (part), 290, 242, (part), 292, 241, 240, 239, 238, 299, 300 and 303 (part) of the said plan, plots Nos. 31, 247 (Vokolidha Village), 110 and 112 of the Government Survey Plan No. XV.8 to the south-eastern corner of the last mentioned plot; thence westwards along the boundaries of and including the said plot, plot No. 111 of the said plan, to the south-western corner of the said plot, which corner is on a track leading to Ayios Theodoros village; thence north-westwards along the said track to the south-western corner of plot No. 214 of the Government Survey Plan No. VII.64, locality "Gipa"; thence northwards along the boundary of and including part of the said plot to the north-western corner of plot No. 172 of the said

plan, which corner is on a track leading from the village of Vokolidha to the village of Ayios Theodoros ; thence westwards along the said road to the south-western corner of plot No. 170 of the said plan ; thence north-westwards along the boundaries of and including the said plot, plots Nos. 168 and 171 (part) of the said plan, plots Nos. 273, 274 and 275 of the Government Survey Plan No. VII.63, to the most western point of the last mentioned plot, which point is on the Famagusta-Karpas main road ; thence south-westwards along the said road to the most southern point of plot No. 329 of the said plan ; thence in a south-westerly direction and including the said plot, plots Nos. 328, 279, 281, 324, 341, 342, 392 (part), 408, 409, 384, 410, 411, 413, 414, 450 (part) and 449 of the said plan, to the south-western corner of the last mentioned plot ; thence northwards, eastwards and north-westwards along the boundaries of and including the said plot, plots Nos. 415, 416, 417, 380, 349 (part), 348 (part), 347 (part), 346 (part), 345, 289 (part), 287 (part), 321, 322, 286 (part), 285, 227 (part), 263, 226, 163, 164 (part), 165, 166, 126, 167, 168, 124 (part), 122 (part), 119 (part) and 117 (part) of the said plan, to the point of commencement, all which said area is shown edged in green on the Government Survey Plan signed by the Director of Agriculture and deposited in his Office at Nicosia.

And that the Soil Conservation Scheme briefly set out in the Appendix hereto will be in operation within the aforesaid area.

APPENDIX.

Forty new spillways will be constructed and the existing dry stone spillways will be reconstructed. A certain amount of levelling and smoothing of the land will follow. Earth bunds will be provided to direct the flow of the floods over the spillways. The waterlogged area called "Limnes" will be reclaimed by drainage.
