THE AGRICULTURAL PRODUCE (EXPORT) REGULATIONS,  
1953 TO 1954.

NOTICE UNDER REGULATION 17.

In exercise of the powers vested in me by regulation 17 of the Agricultural Produce (Export) Regulations, 1953 to 1954, I, the Director of Agriculture, do hereby order that Grapefruit and Oval (Jaffa type) Oranges of the 1955 crop shall be cut after the dates specified herebelow :—

Grapefruit 8 a.m. of Friday 21st October, 1955.

Oval (Jaffa type) Oranges 8 a.m. of Monday, 7th November, 1955.

Grapefruit and Oval (Jaffa type) oranges cut on or after the above-mentioned dates will be required to be passed as mature as prescribed in regulation 17 of the Agricultural Produce (Export) Regulations, 1953 to 1954.

No. 612. THE PUBLIC HEALTH (VILLAGES) LAW.  
CAP. 142.

The following rules made by the Village Health Commission of Timi in the District of Paphos and approved by the Commissioner and the Director of Medical Services, are published in the *Gazette*.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF TIMI UNDER  
SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, Cap. 142, the Village Health Commission of Timi hereby make the following rules :—

1. These rules may be cited as the Village Health (Timi) (Amendment) Rules, 1955, and shall be read as one with the Village Health (Timi) Rules, 1939 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Village Health (Timi) Rules, 1939 and 1955.

2. *Rule 101.* No person shall thresh or winnow grain in such a manner as to cause dust to be blown into the village.
