**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS)  
ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

In exercise of the powers vested in me by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force in consequence of the Supplies and Services (Continuance) Order, 1954), I do by this Order order as follows :—

1. I authorize, subject to the restrictions and conditions contained in the First Schedule to this Order, the use, for military purposes, of the land specified in the Second Schedule (hereinafter referred to as "the land") during the period of six months from the date of this Order.

2. The persons using the land in pursuance of this Order are entitled to do thereon or in relation thereto such acts as may be necessary for military purposes.

3. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this Order shall remain in force.

FIRST SCHEDULE.

1. The land shall be occupied and used for military purposes only.
2. At the expiration of this Order the land shall be restored to the persons entitled thereto free of any erection, structure or construction erected or constructed thereon.
3. Compensation shall be paid to the persons having an interest on the land for its use and occupation under this Order.

SECOND SCHEDULE.

All the privately-owned lands situated in the village of Eylenja, consisting of 50 donums, one evlek and 2,600 square feet or thereabouts and including parts of plots Nos. 553, 254 and 897 and the whole of plots Nos. 554, 555, 556, 557, 558, 559, 563, 564, 565, 566, 567, 568, 569, 570, 571, 572, 573, 574, 575, 576, 577, 578, 579, 580, 581, 582, 583, 584, 585, 586, 587, 588, 589, 590, 591, 592, 593, 594, 595, 596, 597, 598, 599, 600, 601, 602, 603, 604, 605, 606, 607, 608, 609, 610, 611, 612, 613, 614, 615, 616, 617, 618, 619, 620, 621, 622, 629, 630, 631, 632, 633, 720, 721, 722, 723, 724, 725, 726, 727, 728, 729, 730, 731, 732, 733, and 734 of Block B, Eylenja, all which said lands lie within the area coloured red on the Government Survey Plan signed by the Deputy Assistant Director of Hirings, Cyprus, and dated the 3rd October, 1955, a copy of which has been deposited with the Commissioner, Nicosia/Kyrenia.
