**THE LAND ACQUISITION LAW.**  
CAP. 233 AND LAW 26 OF 1952.

NOTICE UNDER SECTION 6.

With reference to Notification No. 599 to the *Gazette* No. 3875 of the 6th October, 1955, whereby the acquisition of certain land situated at Pano Arodhes in connection with the water supply of Peyia Improvement Area was declared by the Governor to be an undertaking of public utility, notice is hereby given that the following land is required by the Governor for the said undertaking of public utility :—

Half share of land under Sheet No. XXXV/Plan No. 57 Plot No. 22, with everything standing thereon.

2. Any person claiming to have any right or interest in the said land who objects to the acquisition is required within six weeks from the date of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

3. The Governor is willing to treat for the acquisition of the said land.

**THE POLICE LAW.**

CAP. 265 AND LAWS 24 OF 1953, 31 OF 1954 AND 21 OF 1955.

ORDER MADE BY THE SENIOR SUPERINTENDENT OF POLICE, LIMASSOL,  
UNDER SECTION 25A.

In exercise of the powers vested in me under section 25A of the Police Law, I, the Senior Superintendent of Police, Limassol, do hereby prohibit between the hours of 6.30 p.m. and 12 midnight on the 6th November, 1955, and for the same period of time on each succeeding day, up to and including the 12th November, 1955, within the area specified in Part I of the Schedule hereto all kinds of vehicular traffic specified in Part II of the said Schedule.
