ORDER MADE BY THE SENIOR SUPERINTENDENT OF POLICE, LIMASSOL, UNDER SECTION 25A.

In exercise of the powers vested in me under section 25A of the Police Law, I, the Senior Superintendent of Police, Limassol, do hereby prohibit between the hours of 6.30 p.m. and 12 midnight on the 20th day of November, 1955, and for the same period of time on each succeeding day, up to and including the 26th November, 1955, within the area specified in Part I of the Schedule hereto all kinds of vehicular traffic specified in Part II of the said Schedule.

Schedule. PART I. The Municipal limits of Limassol. PART II. Motor cycles and Bicycles.

THE PUBLIC HEALTH (VILLAGES) LAW. No. 729. CAP. 142.

The following rules made by the Village Health Commission of Dhrousha in the District of Paphos, and approved by the Commissioner, are published in the Gazette.

> RULES MADE BY THE VILLAGE HEALTH COMMISSION OF DHROUSHA UNDER SECTION 9.

In exercise of the powers vested in them by section 9 (i) (a) of the Public Health (Villages) Law, the Village Health Commission of Dhrousha hereby Cap. 142. make the following rules :---

1. These rules may be cited as the Village Health (Dhrousha) (Amendment) Rules, 1955, and shall be read as one with the Village Health Gazette : (Dhrousha) Rules, 1938 (hereinafter referred to as "the principal Rules") Supplement and the principal Rules and these rules may together be cited as the Village 30.9.1938. Health (Dhrousha) Rules, 1938 and 1955.

2. Rule 20 of the principal Rules is hereby repealed and the following rule substituted therefor :-

"Rule 20. The following fees shall be paid by the owner of or the person slaughtering any animals in the slaughter-house, that is to say :---

(a) For every bullock, camel, cow or ox not exceeding	
thirty okes in weight	50
(b) For every bullock, camel, cow or ox exceeding thirty	-
okes in weight	100
(c) For every goat, kid, lamb or sheep of six okes or over	
in weight	50
(d) For every kid or lamb under six okes in weight	33
(e) For every swine not exceeding five okes in weight	15
(f) For every swine exceeding five okes in weight but not	
exceeding 10 okes in weight	33
(g) For every swine exceeding 10 okes in weight but not	
exceeding 30 okes in weight	
(h) For every swine exceeding 30 okes in weight	100"

exceed 500 mils (c) When the value of the goods exceeds 500 mils but does

Provided that if the value of such goods exceeds f_{1} a fee of 33 mils for each additional pound or fraction thereof shall be added to the aforementioned fee of 33 mils.

"Rule 46.—(1) The following fees shall be paid by every person exposing for sale any fresh meat in the meat market, that is to say :--

5. Rule 58 (A). The following tolls shall be paid by every person selling or exposing for sale in the fair market the following animals, that is to say :--

- mils.
- (a) For every goat, sheep, pig, lamb, kid or pig sold
- (b) For every ox, camel, horse, mule, donkey or calf sold . .(c) For any kind of goods, articles, things, eatables or liquids
 - exposed for sale for the whole or any part of the period of the said fair, a fee from 15 mils to 100 mils according to the value or quantity thereof, to be determined in each case by the Village Health Commission.
