**BYE-LAWS MADE BY THE IMPROVEMENT BOARD OF ASHA.**

39 of 1950  
 31 of 1953.

In exercise of the powers vested in them by section 24 of the Villages (Administration and Improvement) Laws, 1950 and 1953, the Improvement Board of Asha hereby make the following bye-laws :—

1. These bye-laws may be cited as the Villages (Administration and Improvement) Asha (Amendment) Bye-laws, 1955, and shall be read as one with the Villages (Administration and Improvement) Asha Bye-laws, 1951 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Villages (Administration and Improvement) Asha Bye-laws, 1951 and 1955.

Bye-law 172 (4) of the principal Bye-laws is hereby deleted and the following bye-law substituted therefor :—

"Bye-law 172.—(4) The following fees shall be paid by every person for a licence or renewal of a licence to keep any dog within the improvement area, that is to say :—

(a) For the first dog .. .. .	4/-
(b) For each additional dog .. .. .	5/-
(c) For the first bitch .. .. .	6/-
(d) For each additional bitch .. .. .	7/-."

The above bye-laws have been approved by the Colonial Secretary.
