## ORDER IN COUNCIL No. 2813

MADE UNDER SECTION 60 (d).

In exercise of the powers vested in him by paragraph (d) of section 60 of the Criminal Code, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :—

1. This Order may be cited as the Unlawful Association (Neos Democratis) Order, 1955.

2. The body of persons responsible for the publication of the newspaper "Neos Democratis" is hereby declared to have among its aims the promotion of disorder and of the spread of sedition within the Colony and to be proscribed within the Colony.

3. This Order shall remain in force for a period of twelve months from the date of its publication in the *Gazette* and no longer unless renewed for such period or periods, not exceeding twelve months at any one time, as the Governor-in-Council may direct by order published in the *Gazette*.

2. The body of persons responsible for the publication of the newspaper "Theoreticos Democratis" is hereby declared to have among its aims the promotion of disorder and of the spread of sedition within the Colony and to be proscribed within the Colony.

3. This Order shall remain in force for a period of twelve months from the date of its publication in the *Gazette* and no longer unless renewed for such period or periods, not exceeding twelve months at any one time, as the Governor-in-Council may direct by order published in the *Gazette*.
