NOTICE UNDER SECTIONS 2, 3 AND 5.

Whereas it has been represented to me that it is desirable in the public interest to establish and operate a radio relay station in the District of Paphos, together with such buildings, erections, structures and other installations as may be necessary to operate and maintain such radio relay station, the cost whereof is to be borne by the Government of Cyprus.

Now, therefore, in exercise of the powers vested in me by sections 2, 3 and 5 of the Land Acquisition Law, I, the Administrative Secretary, do hereby declare the establishment and operation of the radio relay station to be an undertaking of public utility and do hereby authorize the carrying out of the said undertaking and do hereby entrust the Director of Broadcasting, or in his absence the person acting for the time being as Director of Broadcasting, with the supervision and effectuation of the said undertaking.

United Nations Statistical Papers Series M. No. 10, Indexed Edition, April, 1953, and this Open General Licence shall not apply to any goods unless such goods are goods to which the corresponding Division, Group or Item of the Standard International Trade Classification applies.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955.

NOTICE UNDER REGULATION 44.

In exercise of the powers vested in His Excellency the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Cyprus Gazette* of the 26th November, 1955, I hereby give notice that in the interests of public order and safety and for maintaining supplies and services essential to the life of the community I have taken possession until further notice of the land specified in the Schedule hereto.

2. The use of the said land as Government Offices, and for the time being to accommodate the office of the Official Receiver and Registrar is hereby authorised.

3. The authority using the land in pursuance of this order is entitled to do thereon or in relation thereto such acts as may be necessary for the purposes of their occupation.
