

4. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this order shall remain in force.

SCHEDULE.

The land, buildings and all appurtenances thereto of the property under plot Nos. 33 and 36/1 of Block No. 10, Iplik Pazar and Korkut Effendi Quarter, Nicosia, excluding the first storey of the buildings with the access thereto on the ground storey and so much of the land and ground storey buildings as is coloured red on the plan signed by me, dated the 13th December, 1955, and deposited in my office at Nicosia. The boundaries of the said plots Nos. 33 and 36/1 are shown edged black on the said plan.

THE EMERGENCY POWERS (COLLECTIVE PUNISHMENT)
REGULATIONS, 1955.

ORDER MADE UNDER REGULATION 3.

I, the Commissioner of Famagusta, in exercise of the powers vested in me by Regulation 3 of the Emergency Powers (Collective Punishment) Regulations, 1955, and with the approval of the Governor, do hereby order that a fine of £1,500 (one thousand and five hundred pounds) be levied collectively on the assessable inhabitants of the village area of Paralimni.

THE TREE PLANTING (VILLAGE AREAS) LAW.

CAP. 175 AND LAW 56 OF 1955.

ORDER MADE UNDER SECTION 12.

Whereas at a meeting duly convened and held at the village of Silikou in the District of Limassol on the 6th June, 1954, under the provisions of the Tree Planting (Village Areas) Law, Cap. 175, it was determined by the requisite majority of the owners present thereat that certain areas should be reserved as a Tree Planting Area of the said village of Silikou ;

And whereas the Mukhtar of the said village of Silikou has forwarded to me a report signed and sealed by him containing a description of the areas in question with boundaries and particulars (which area has been reduced by me to conform with the conditions prescribed in section 10 (4) of the above Law) ;

Now, therefore, I, the Commissioner of the District of Limassol, do by this Order declare that the areas described in the Schedule hereto shall be reserved as the Tree Planting Area of the said village of Silikou.

SCHEDULE.

Area A.

The area lying within the following boundaries, that is to say :—

The boundary commences at the most western point of plot No. 399 of the Government Survey Plan No. XLVII.36, locality " Poroudhia ", and proceeds north-eastwards and south-eastwards along the boundaries of and including the said plot, plots Nos. 401, 402, 546, 509, 508, 507, 506, 412, 413, 414, 501, 426, 427, 497, 444, 445, 447, 446, 456, 458, 459, 474, 470, 702, 703, 704 and 711 of the said plan, plots Nos. 910, 911, 912, 928, 937, 936 and 935 of the Government Survey Plan No. XLVII.37 to the most southern point of the last mentioned plot, which point is on a road leading from the Silikou village to the Limassol-Troodos main road ; thence westwards along the said road to the most western point of plot No. 954 of the said plan, locality " Samakeri " ; thence north-westwards along the boundaries of and including the said plot, plots Nos. 934, 930, 932 of the said plan, plots Nos. 721, 722, 723, 724, 725, 726, 727, 729, 728, 696, 695, 694, 692, 490, 690, 491, 611, 610, 536, 537, 538, 607, 606, 616 and 603 of the Government Survey Plan No. XLVII.36, to the most southern point of the last mentioned plot, locality " Phrangoudhia ", which point is on a track ; thence north-westwards along the said track to the point of commencement.

Area B.

The area lying within the following boundaries, that is to say :—

The boundary commences at the most northern point of plot No. 821, of the Government Survey Plan No. XLVII.44, locality " Laoupania ", and proceeds north-eastwards and south-eastwards along the boundaries of and including the said plot, plots Nos. 802, 716, 800, 799, 798, 797, 796, 774, 772 and 771 of the said plan, plots Nos. 84, 17, 18, 79, 78, 76, 71, and 115 of the Government Survey Plan No. XLVII.45, to the south-eastern corner of the last mentioned plot, which corner is on the village boundary between the villages of Silikou and Ayios Yeoryios ; thence in a south-westerly direction along the said village boundary to the south-western corner of plot No. 888 of the Government Survey Plan No. XLVII.44, which corner is on a track, leading from the village of Ayios Yeoryios to the village of Silikou ; thence in a northerly direction along the said track to the point of commencement, all which said areas A and B comprise 974 donums or thereabouts, and are shown edged in red on the Government Survey Plan Serial No. 1644.
