Authority to the Improvement Board of Agros to contract a loan.

In exercise of the powers vested in me by section 22 (a) (i) of the Villages (Administration and Improvement) Laws, 1950 and 1953, I, the Colonial Secretary, do hereby order as follows:—

r. The Improvement Board of Agros (hereinafter referred to as "the Board") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lenders") a sum not exceeding seven thousand and five hundred pounds (£7,500) at a rate of interest not exceeding four per centum (4%) per annum, subject to the following terms and conditions, that is to say:—

(a) the sum borrowed shall be repayable by the Board to the Lenders in twenty equal annual instalments (comprising sinking fund and interest);

(b) the sum borrowed shall be utilized by the Board for the village

water supply.

2. For the purpose of securing the repayment of the sum under the loan, the Board shall, subject to any prior mortgage thereon, mortgage to the Lenders all the rates, fees, rents, tolls or charges now payable or hereafter to become payable to the Board.

No. 82. THE CONTAGIOUS DISEASES (ANIMALS) LAW. CAP. 65.

CONTAGIOUS DISEASES (ANIMALS) GENERAL ORDERS AND REGULATIONS. In exercise of the powers vested in him by section 4 of the Contagious Diseases (Animals) Law, His Excellency the Governor has been pleased to make the following general orders and regulations:—

1. These general orders and regulations may be cited as the Contagious Diseases (Animals) (Amendment) General Orders and Regulations, 1955, and shall be read as one with the Contagious Diseases (Animals) General Orders and Regulations (hereinafter referred to as "the principal Orders and Regulations").

S.L. Vol. I p. 67. 2. The principal Orders and Regulations are hereby amended by the insertion therein of the following paragraph immediately after paragraph 46 thereof:—

"Importation of animal carcasses.

46A. For the purposes of General Orders and Regulation 46B—
'animals' means bulls, cows, oxen, heifers, calves, sheep, goats, swine, rabbits and poultry.

46B. The importation into the Colony of the carcass of an animal is hereby prohibited save under licence under the hand of the Director of Agriculture and subject to such terms and conditions as may be

prescribed in such licence.

46c. The licence required under General Order and Regulation 46B is in addition to, and not in derogation of, any other licence, permit or other formality required for the importation of goods generally under any other law provided."

No. 83. THE PUBLIC HEALTH (VILLAGES) LAW. CAP. 142.

Authority to the Village Health Commission of Milea (Famagusta District) to contract a loan.

In exercise of the powers vested in him by section 10 of the Public Health (Villages) Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows:—

- the Village Health Commission of Milea (Famagusta District) (hereinafter referred to as "the Village Health Commission"), shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lender.") the sum of eight hundred pounds (£800) at a rate of interest not exceeding four per centum (4%) per annum, subject to the following terms and conditions, that is to say:—
 - (a) the sum borrowed shall be repayable by the Village Health Commission to the Lender in five equal annual instalments (comprising sinking fund and interest);
 - (b) the Village Health Commission shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on its revenues the annual instalment payable in the year to which such estimates relate;
 - (c) the sum borrowed shall be utilized by the Village Health Commission for the purpose of improving the streets within the village.
- 2. For the purposes of securing the repayment of the sum due under the loan the Village Health Commission is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Lender all the fees, charges and rates now payable or hereafter to become payable to the Village Health Commission under the provisions of the Public Health (Villages) Law.
