

SECOND SCHEDULE.

All those areas of privately-owned lands situated at Kato Polemidhia Village, that is to say :—

THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

In exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force in consequence of the Supplies and Services (Continuance) Order, 1955), His Excellency the Governor by this Order, orders as follows :—

1. Subject to the restrictions and conditions contained in the First Schedule to this Order, the use, for military purposes, of the land and property specified in the Second Schedule (hereinafter referred to as "the land") during the period of six months from the date of this Order is hereby authorized.
2. The persons using the land in pursuance of this Order are entitled to do thereon or in relation thereto such acts as may be necessary for such military purposes.
3. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this Order shall remain in force.

FIRST SCHEDULE.

1. The land shall be occupied and used for military purposes only.
2. At the expiration of this Order the land shall be restored to the persons entitled thereto free of any erection, structure or construction erected or constructed thereon after the making of this Order.
3. Compensation shall be paid to the persons having an interest on the land for its use and occupation under this Order,

SECOND SCHEDULE.

All those areas of privately-owned land situated at the locality "Soro" in the village of Phrenaros, that is to say :—

The lands forming part of plots Nos. 190A, 196 and 189, the whole of plots Nos. 191, 192, 193, 194 and 195 of the Government Survey Plan No. XXXIII.35, more particularly defined as the areas coloured red in the plan signed by the Assistant Director of Hirings, Cyprus, and dated the 1st February, 1956, a copy of which has been deposited in the office of the Commissioner, Famagusta.

LAND ACQUISITION LAW.

CAP. 233 AND LAW 26 OF 1952.

NOTICE UNDER SECTIONS 2, 3 AND 5.

Whereas it has been represented to His Excellency the Governor that it is desirable in the public interests to widen, improve and realign the public road between Nicosia and Limassol by stages as may from time to time be decided (hereinafter referred to as "the road").

Now, therefore, in exercise of the powers vested in him by sections 2, 3 and 5 of the Land Acquisition Law, His Excellency the Governor does hereby declare the widening, improving and realigning of the road to be an undertaking of public utility, and does hereby authorise the carrying out of the said Law, and does hereby entrust the supervision and effectuation of the said undertaking to the Director of Public Works.

THE LAND ACQUISITION LAW.

CAP. 233 AND LAW 26 OF 1952.

NOTIFICATION UNDER SECTIONS 2, 3 AND 5.

Whereas it has been represented to His Excellency the Governor that it is desirable in the public interest to establish a Technical Trade School in Lefka, and to acquire certain lands for the purpose within the limits of Lefka village :

Now, therefore, in exercise of the powers vested in the Governor by sections 2, 3 and 5 of the Land Acquisition Law, His Excellency the Governor
