THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.

ORDER MADE BY A COMPETENT AUTHORITY UNDER DEFENCE REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of Defence Regulation 61 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force under the Supplies and Services (Continuance) Order, 1953, I hereby order as follows :—

1. This Order may be cited as the Defence (Registration of Importers) Order, 1956.

2. In this Order, unless the context otherwise requires :—

"imported article" means any article imported into the Colony from any place outside the Colony ;

"importer" means any person who either directly or indirectly imports into the Colony any imported article :

Provided that in the case of any goods consigned to any person in the Colony for the account of any person abroad, the person to whom the goods are consigned in the Colony shall be deemed to be the importer.

3. No person shall import into the Colony any imported article unless such person is an importer registered under the provisions of this Order :

Provided that a person who is not a registered importer may import any goods by virtue of a specific licence issued in his name under the Defence (Importation of Goods) Regulations, 1956.

4.—(i) Any person who wishes to register as an importer shall apply to me in writing in the form set out in the First Schedule giving all the prescribed particulars and requesting registration.

(ii) Upon receipt of an application as in sub-clause (i) hereof provided I may register the applicant as an importer and issue to him a certificate of registration under my hand or the hand of any person duly authorised by me on that behalf in the form set out in the Second Schedule hereto, which may contain such terms, limitations and conditions as I may think fit to impose.

(iii) A certificate issued under sub-clause (ii) of this clause shall be exhibited by the holder thereof in a conspicuous place in such premises as may be specified in such certificate.

(iv) Any person aggrieved by any decision taken by me under sub-clause (ii) of this clause, may within seven days from the date of the notification of such decision appeal to the Governor in Council, whose decision thereon shall be final and conclusive.

5. There shall be charged and paid in respect of every certificate of registration issued under the provisions of this Order a fee of five pounds :

Provided that where I am satisfied that a person was on the date of this Order registered as an importer under the provisions of the Defence (Registration of Importers and Resellers) Order, 1954, no fee shall be charged in respect of a certificate of registration under this Order duly applied for not later than 30th November, 1956.

6. Any person who—

(a) acts in contravention of, or fails to comply with, any of the provisions of this Order ;

(b) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this Order,

is liable to the penalties prescribed in the Defence Regulations, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946.

7. The Defence (Registration of Importers and Resellers) Order, 1954, is hereby revoked without prejudice to anything done or left undone thereunder.

EXPLANATORY NOTE.

(This note is not part of the Order but is intended to indicate its general purport.)

This Order replaces the Defence (Registration of Importers and Resellers) Order, 1954. It requires all persons wishing to import goods into Cyprus to register with the Director of Commerce and Industry. Importers registered under the Order now revoked are required to re-register under the new Order, but will be exempted from paying any fee provided their application is received in the prescribed form on or before the 30th November, 1956.

The registration of resellers who are not importers is no longer required.
