In exercise of the powers vested in him by sections 7 and 8 of the Customs Management Laws, 1954 and 1955, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :—

2. This Order may be cited as the Customs Management (Ports, Aerodromes and Shipping Places) (Amendment) Order, 1956, and shall be read as one with the Customs Management (Ports, Aerodromes and Shipping Places) Orders, 1954 and 1955 (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Customs Management (Ports, Aerodromes and Shipping Places) Orders, 1954 to 1956.

3. Paragraph 4 of the principal Order is hereby amended by the substitution for the words "Dhekelia, Latchi and Moni" of the words "Dhekelia, Latchi, Moni and Akrotiri".

4. The areas specified in the first column of Part II of the Schedule to the principal Order, under the headings of Dhekelia, Latchi and Moni respectively, appointed to be ports for the limited purposes set out in the second column of the said Part, shall be amended by the addition thereto of the following :—

<p>Akrotiri :</p> <p>The territorial waters of Cyprus contained within Latitude 34° 33' 48" North and Latitude 34° 34' 48" North on Admiralty Chart No. 846 of the 3rd February, 1939.</p> <p>(Plan of Limassol).</p>	<p>The discharge of oil cargoes through submarine pipe line into shore tanks.</p>

THE BURIALS LAW.

CAP. 53 AND LAW 33 OF 1955.

ORDER UNDER SECTION 15.

Whereas in pursuance of Notification No. 134 published in Supplement No. 3 to the *Gazette* of the 12th March, 1953, a fit and proper site has been registered in the books of the Land Registry Office as a burial ground for the burial of the dead by the Turkish community of Melounda village in the District of Famagusta :

Now, therefore, in exercise of the powers vested in the Governor by section 15 of the Burials Law and duly delegated to me under Notification No. 172 published in Supplement No. 3 to the *Gazette* of the 19th June, 1947, I do hereby order that from and after the 15th November, 1956, no burial shall take place in the burial ground in lieu whereof the new burial ground above referred to has been provided.
