ORDER UNDER SECTION 6 (2).

In exercise of the powers vested in him by section 6 (2) of the Elementary Education Law the Governor does hereby order as follows :—

1. This Order may be cited as the Elementary Education (Prescription of Groups) (Amendment) Order, 1956, and shall be read as one with the Elementary Education (Prescription of Groups) Orders, 1951 and 1953 (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Elementary Education (Prescription of Groups) Orders, 1951 to 1956.

2. The First Schedule to the principal Order is hereby amended by the insertion therein immediately after the words "Greek-Orthodox, Khrysiliou, Morphou" of the following words in their respective columns "Greek-Orthodox, Kato Dherinia, Famagusta".

No. 1078.**THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES LAW.**

CAP. 311 AND LAWS 28 OF 1951 AND 12 OF 1952.

NOTIFICATION UNDER SECTION 12 (4).

Whereas immovable property is required by the Water Commission of Sykhari, Kyrenia District, in connection with a scheme for the supply, and/or maintenance of a supply, of water for the domestic purposes of the inhabitants of the said village ;

And whereas the Commissioner of Kyrenia in compliance with section 12 (2) of the Water (Domestic Purposes) Village Supplies Law, by notice published under Notification No. 513 in Supplement No. 3 to the *Gazette* of the 14th June, 1956, and posted at a conspicuous place in the village concerned, gave a description and particulars of the immovable property required as aforesaid (hereinafter referred to as "the immovable property") and required any person claiming any right or interest therein to submit his claim with the necessary evidence in support thereof within the period therein set out ;

And whereas the Commissioner of Kyrenia at the expiration of the period set out in the aforesaid notice forwarded to the Governor two plans of the immovable property together with particulars as regards its owners, description and estimated value ;

And whereas the Governor has approved the plans submitted and considers it expedient, having regard to all the circumstances, that the Water Commission of Sykhari should be permitted to acquire the immovable property :

Now, therefore, in exercise of the powers vested in him, by section 12 (4) of the Water (Domestic Purposes) Village Supplies Law, His Excellency the Governor has been pleased to sanction the acquisition of the immovable property.

THE ANTIQUITIES LAW.

CAP. 43.

REGULATIONS MADE UNDER SECTION 35 (d).

In exercise of the powers vested in him by section 35 (d) of the Antiquities Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to make the following regulations :—

1. These Regulations may be cited as the Antiquities (Amendment) Regulations, 1956, and shall be read as one with the Antiquities Regulations (hereinafter referred to as "the principal Regulations").

2. Regulation 12 is hereby amended by the deletion of the words "ten shillings" occurring therein and the substitution therefor of the words "five hundred mils".

3. Paragraph (1) of Regulation 17 of the principal Regulations is hereby revoked and replaced by the following :—

"(1) In this part of these Regulations—
'resident' means—

- (i) any person who ordinarily resides in the Colony ;
- (ii) any officer or other rank of Her Majesty's Naval, Military or Air Forces ; and
- (iii) any officer or other rank of an Allied Naval, Military or Air Force stationed in the Colony."

4. Regulation 18 of the principal Regulations is hereby amended by the deletion of the words "five shillings" from the first proviso thereto and the substitution therefor of the words "five hundred mils".
