And whereas Her Majesty's Secretary of State for the Colonies has given his consent to the making of a declaration as aforesaid :

Now, therefore, in exercise of the powers vested in me by the said section 189 of the Army Act, and of every other power and authority enabling me in that behalf, I, the Governor, do hereby declare and proclaim that by reason of the imminence of active service it is necessary for the public service that Her Majesty's forces in the Colony subject to the Army Act should be temporarily subject to the said Army Act as if they were on active service for the period commencing on the 26th day of November, 1956, and ending on the 31st day of December, 1956.

THE AIR FORCE ACT.

(7 & 8 Geo. 5.)

PROCLAMATION UNDER SECTION 189.

Whereas by sub-section (2) of section 189 of the Air Force Act of the United Kingdom, as continued in force by Act of Parliament for the time being, it is provided, *inter alia*, that the Governor of a Colony in which any part of Her Majesty's air force is serving may declare at any time that, by reason of the imminence of active service, it is necessary for the public service that the force in the Colony should be temporarily subject to the Air Force Act, as if it was on active service :

And whereas by a Proclamation dated the 3rd day of December, 1955, and published in the *Gazette* of that date, it was declared that by reason of the imminence of active service it was necessary for the public service that Her Majesty's air force in the Colony subject to the Air Force Act should be temporarily subject to the said Air Force Act as if it was on active service for a period of three months from the date of the aforesaid declaration :

And whereas by a further Proclamation dated the 23rd day of February, 1956, and published in the *Gazette* of that date, the said declaration was renewed for another period of three months from the 3rd day of March, 1956 :

And whereas by a further Proclamation dated the 23rd day of May, 1956, and published in the *Gazette* of the 25th day of May, 1956, it was declared that by reason of the imminence of active service it was necessary for the public service that Her Majesty's air force in the Colony subject to the Air Force Act should be temporarily subject to the said Air Force Act as if it was on active service for a period of three months from the 3rd day of June, 1956 :

And whereas by a further Proclamation dated the 23rd day of August, 1956, and published in the *Gazette* of the 24th day of August, 1956, the last-mentioned declaration was renewed for another period of three months from the 3rd day of September, 1956 :

And whereas the last-mentioned period expires on the 2nd day of December, 1956 :

And whereas I am satisfied that, by reason of the imminence of active service, it is necessary for the public service that the air force in the Colony should be temporarily subject to the Air Force Act, as if it was on active service :

And whereas Her Majesty's Secretary of State for the Colonies has given his consent to the making of a declaration as aforesaid :

Now, therefore, in exercise of the powers vested in me by the said section 189 of the Air Force Act, and of every other power and authority enabling me in that behalf, I, the Governor, do hereby declare and proclaim that by reason of the imminence of active service it is necessary for the public service that Her Majesty's air force in the Colony subject to the Air Force Act should be temporarily subject to the said Air Force Act as if it was on active service for the period commencing on the 3rd day of December, 1956, and ending on the 31st day of December, 1956.

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 14) 1956.**

ORDER MADE UNDER REGULATION 34 (1).

In exercise of the powers vested in me by Regulation 34 (1) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 14) 1956, I, the Governor, do hereby order as follows :—

1. This Order may be cited as the Emergency Powers (Control of Motor Transport) (No. 2) Order, 1956.

2.—(1) Notwithstanding anything in any Law or public instrument contained, the vehicles specified in the Schedule hereto shall not be used on any road within the Colony unless the person driving such vehicle is in possession of a permit granted to him under the hand of the Commissioner of Police, or under the hand of any person authorised by him in that behalf, and subject to such terms and conditions as may be specified in such permit.

(2) A permit granted under this Order may be cancelled at any time.

3. Nothing in this Order contained shall apply to any person acting in the course of his duty as—

- (a) a member of Her Majesty's Forces ; or
- (b) a member of the Cyprus Police Force ; or
- (c) a member of the Special Constabulary.

4. This Order shall be in addition to, and not in derogation of, the Emergency Powers (Control of Motor Transport) Order, 1956.

5. This Order shall come into force on a date to be fixed by the Governor by a notice published in the *Gazette*.

SCHEDULE.

Motor vehicles licensed as—

- (i) motor bicycles (with or without side-car) ;
- (ii) motor tricycles ;
- (iii) autocycles ;
- (iv) private motor vehicles ;

under the provisions of the Motor Vehicles Regulations, 1951 to 1955, or of any regulations amending or substituted for the same.
