

No. 1118. THE LAND ACQUISITION LAW.

NOTIFICATION UNDER SECTION 7.

Whereas by Notification No. 497 published in Supplement No. 3 to the *Gazette* of the 12th August, 1954 (as amended by Notification No. 561 published in Supplement No. 3 to the *Gazette* of the 9th September, 1954), the Governor declared the provision of new main roads in the town of Nicosia and in the villages of Ayios Dhometios, Strovolos, Orta Keuy and Engomi, and the protection thereof to be an undertaking of public utility;

And whereas the Commissioner of Nicosia and Kyrenia in compliance with section 6 of the Land Acquisition Law, by a notice published under Notification No. 514 in Supplement No. 3 to the *Gazette* of the 14th June, 1956, gave particulars of a portion of the lands required in connection with the aforesaid undertaking (hereinafter referred to as "the lands");

And whereas the Commissioner of Nicosia and Kyrenia forwarded to the Governor the required recommendations, plans and particulars together with the objections made;

And whereas, having considered the objections made thereto the Governor has approved the plan and particulars submitted, and has considered it expedient, having regard to the circumstances of the case, that the lands be acquired:

Now, therefore, in exercise of the powers vested in him by section 7 of the Land Acquisition Law, the Governor hereby sanctions the acquisition of the lands under the provisions of the said Law.

NOTICE UNDER SECTION 7.

Whereas by Notification No. 665 published in Supplement No. 3 to the *Gazette* of the 25th November, 1954, the Governor declared the carrying out of the Improvement and Development of the Famagusta Port, to be an undertaking of public utility;

And whereas the Commissioner, Famagusta, by a notice published under Notification No. 675 in Supplement No. 3 to the *Gazette* of the 25th November, 1954, gave particulars of the lands (hereinafter referred to as the "lands") required in connection with the aforesaid undertaking;

And whereas the Commissioner, Famagusta, forwarded to the Governor the required recommendations, plan and particulars, together with the objections made;

And whereas the Governor has approved the plan and particulars submitted, and has considered it expedient, having regard to all the circumstances of the case, that only that part of the lands described in the Schedule hereto should be acquired :

Now, therefore, in exercise of the powers vested in him by section 7 of the Land Acquisition Law, the Governor hereby sanctions the acquisition of that part of the lands described in the Schedule hereto.

SCHEDULE.

All those areas of privately owned lands, with everything standing thereon, situated at Ayios Loukas Quarter, Famagusta Town, comprising 142 donums, two evleks and 1,200 square feet or thereabouts, and including parts of plots Nos. 182, 30, 685, 54, 53, 51, 50, 49 and 55 and the whole of plots Nos. 34, 35, 36, 231 and 353 of Block C, more particularly defined as the areas coloured red and green on the plan marked "Improvement of Famagusta Port" and dated the 17th November, 1956, deposited in the office of the Commissioner of Famagusta.

The areas coloured green on the said plan shall form "road protecting strips" and shall not be ceded to the public road.

NOTICE UNDER SECTION 6.

With reference to the Notification No. 665 published in Supplement No. 3 to the *Gazette* of the 25th November, 1954, notice is hereby given that the following land is required for the undertaking of public utility mentioned therein :—

All that area of privately owned land, with everything standing thereon, comprising 3 donums, 2 evleks, and 200 sq. ft. or thereabouts, forming part of plot No. 400 of Block C, Ayios Loukas Quarter, Famagusta Town, more particularly defined as the area coloured red on the plan signed by the Director of Public Works and dated the 3rd November, 1956.

2. Any person claiming to have any right or interest in the said land who objects to the acquisition is required within six weeks from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

3. The Government is willing to treat for the acquisition of the said land.

4. A plan showing the land described above is available for inspection at my office.
