LAWS 17 AND 47 OF 1955.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Nicosia District No. 38) Order, 1956.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Commissioner of Police in charge of the area.

3. Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 17th day of November, 1956.

FIRST SCHEDULE.

The area of Ayios Dhometios within the bounds of Yannina street, Wright street, Kykko street and Clemens street.

SECOND SCHEDULE.

From 05.00 hrs. until further notice.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 618 published in Supplement No. 3 to the *Gazette* of the 13th October, 1955, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Famagusta District No. 17A) Order, 1956.

2. No Greek Cypriot born on or after the 1st of January, 1930, shall be out of doors within the area prescribed in the First Schedule hereto between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Famagusta or the Assistant Commissioner of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 3rd day of November, 1956, and shall remain in force until further notice.

Within the Municipal area of Famagusta.

SECOND SCHEDULE.

Between 17.30 hours and 05.00 hours.

1. This Order may be cited as the Curfews (Famagusta District No. 19) Order, 1956.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Famagusta or the Assistant Commissioner of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

This Order shall come into force on the 14th day of November, 1956, and shall remain in force until further notice.

FIRST SCHEDULE.

Within the village boundaries of Gypsos.

SECOND SCHEDULE.

Between 17.30 hours and 05.00 hours.
