## NOTICE UNDER SECTION 6.

With reference to the Notification No. 986 published in Supplement No. 3 to the *Gazette* of the 18th October, 1956, notice is hereby given that the following lands are required for the undertaking of public utility mentioned therein :—

With reference to the Notification No. 665 published in Supplement No. 3 to the *Gazette* of the 25th November, 1954, notice is hereby given that the following lands are required for the undertaking of public utility mentioned therein :—

All those areas of privately owned lands, with everything standing thereon situated within the Famagusta Town, comprising 54 donums or thereabouts, forming parts of plots Nos. 56 to 61, 64, 63, 479, 478, 101, 102 and 104 of Block C, Ayios Loukas Quarter, parts of plots Nos. 5, 227, 435, 436, 61, 65, the whole of plots Nos. 679 to 684, parts of plots Nos. 666, 685, 342, 526, 527, 163, 190, 164, the whole of plots Nos. 524, 525, 443, 444, 183, parts of plots Nos. 374, 174, the whole of plots Nos. 343, 674, 658, parts of plots Nos. 673, 659 and 572 of Block A, of the same quarter, parts of plots Nos. 842 and 600 of Block B, Kato Varosha Quarter, parts of plots Nos. 1, 672, 673, and 112 of Block A of the same quarter, parts of plots Nos. 36, 37 and the whole of plot No. 35 of Block A, Ayios Nikolaos quarter, more particularly defined as the areas coloured yellow and green on the plan signed by the Director of Public Works and dated the 28th November, 1956, deposited in the office of the Commissioner, Famagusta.

*Note* : The areas coloured green on the said plans are to form "road protecting strips" and shall not be ceded to the public road.
