**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.**

ORDER MADE BY THE COMPETENT AUTHORITY UNDER DEFENCE
REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of Defence Regulation 61, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force in consequence of the Supplies and Services (Continuance) Order, 1955), I hereby order as follows:—

1. This Order may be cited as the Petroleum (Restrictions) Order, 1956.
2. In this Order—
 - “Controller” means the Director of Commerce and Industry and includes any person appointed by him by notice in the *Gazette* to be an Assistant Controller of Petroleum and any person duly authorised by him to perform all or any of the duties of the Controller;
 - “enforcement officer” means any person duly authorised by the Controller to enforce all or any of the provisions of this Order or of any direction thereunder;
 - “petroleum” has the meaning ascribed to it in section 2 of the Petroleum Law.
3. The Controller may, for the purpose of securing an equitable distribution of petroleum, from time to time give such directions as he may think fit—
 - (a) to all or any petroleum distributors as to—
 - (i) the possession of petroleum;
 - (ii) the distribution, sale or other disposal of petroleum.
 - (b) to any person as to—
 - (i) the registration of vehicles and plant for the operation of which any petroleum is required;
 - (ii) the possession of petroleum;
 - (iii) the purchase of petroleum.
4. No person shall possess any petroleum save in accordance with directions given from time to time by the Controller.
5. Where any direction is given under the provision of this Order, the authority issuing the direction shall cause notice of such direction to be given as soon as may be in such manner as he thinks necessary for bringing it to the notice of all persons who, in his opinion, ought to have notice of the direction.

6. The Controller and any enforcement officer may, in pursuance of his duties under this Order, at all reasonable times enter the premises of any petroleum distributor.

7. Where, in the opinion of the Controller, any petroleum is in the possession of any person in contravention of any provision of this Order or of any direction thereunder, the Controller or any enforcement officer may order such person to deliver such petroleum to such place as he may direct, and the cost of delivery shall be borne by such person.

8. Any person failing to comply with, or acting in contravention of, this Order, or of any direction or any term or condition of any direction given under this Order, shall be guilty of an offence against this Order and shall be liable to the penalties prescribed in the Defence Regulations, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946.

THE PETROLEUM (RESTRICTIONS) ORDER, 1956.

NOTICE UNDER SECTION 2.

In exercise of the powers vested in me by section 2 of the Petroleum (Restrictions) Order, 1956, I, the Director of Commerce and Industry, do hereby appoint Ares Victor Zachariades, Esq., M.B.E., to be Assistant Controller of Petroleum for the purposes of the said Order.

No. 1188. THE PETROL (RESTRICTIONS) ORDER, 1956.

DIRECTION UNDER SECTION 3A TO PERSONS IN CHARGE OF PETROL FILLING STATIONS.

No person in-charge-of or employed in any petroleum filling station or other distribution centre shall sell or dispose of any motor spirit save in accordance with the following conditions :—

- (a) With effect from the 3rd day of December, 1956, the motor spirit shall be delivered into the tank of such vehicle ;
 - (b) With effect from the 10th December, 1956—
 - (i) the motor spirit shall be supplied upon the surrender to him of valid purchase coupon or coupons ;
 - (ii) no sale of motor spirit shall exceed the maximum quantity for which the coupon or coupons surrendered are valid as published from time to time in the *Gazette* by the Controller of Petroleum.
2. Notwithstanding anything contained in this Order a person in charge of a petrol filling station may sell petrol to any person specially authorised by the Controller of Petroleum subject to such terms or conditions as the Controller of Petroleum may impose.
