REGULATIONS MADE UNDER ARTICLES 51 AND 68.

In exercise of the powers vested in the Governor by Articles 51 and 68 of the Colonial Air Navigation Order, 1955, and of every other power thereunto enabling, His Excellency the Governor hereby makes the following regulations :—

1. These regulations may be cited as the Air Navigation (Licensing of Aerodromes) Regulations, 1956.

2. An application for the grant or renewal of a licence in respect of an aerodrome shall be made in the form and manner and shall contain the particulars prescribed in the First and Second Schedules hereto. Every applicant shall furnish to the Governor or any person authorized by him such further information as may reasonably be required by him for determining the application.

3. A licence to use an aerodrome issued under this regulation shall remain in force for a period of one year and may be renewed for a further period or periods of one year with or without variation of any conditions previously contained in the licence.
