THE CURFEWS LAWS, 1955-
LAWS 17 AND 47 OF 1955.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows:—

1. This Order may be cited as the Curfews (Limassol District No. 30) Order, 1956.

2. No person within the area prescribed in the Schedule hereto shall be out of doors between the hours of 2 p.m. and 4 p.m. on Saturday 24th November, 5 a.m.—7 a.m. and 9.30 a.m. to 5.30 p.m. on Sunday the 25th November, 1956, except under the authority of a written permit granted by the Commissioner of Limassol or the Assistant Commissioner of Police in charge of the area:

Provided that this Order shall not apply to any person who is not a Greek Cypriot born on or after the 1st January, 1930.

No. 1204. THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 16) 1956.

ORDER MADE UNDER REGULATION 38A.

In exercise of the powers vested in the Governor by regulation 38A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 16) 1956, the Governor's Deputy considering it necessary in the public interest so to do, hereby orders that the three areas described in the first column of the Schedule hereto, excluding the area described in the second column of the said Schedule, be declared danger areas.

The limits and extent of the said areas shall be demarcated by notices in English, Greek and Turkish put up at the point where each road or recognised track enters each of the said areas, and on any prominent and accessible feature lying in the boundaries of each of the said areas.

2. This Order may be cited as the Danger Area (Paphos District No. 1) Order, 1956, and shall come into force on the 6th December, 1956.

Area "A": All that area within a radius of 300 yards on either side of the Ktima-Coral Bay road and commencing from the north-western boundary of Plot 4 of Government Survey Plan Sheet No. XLV.25 (near Coral Bay); thence eastwards and south-eastwards and ending on a straight line from the south-eastern corner of Plot 113 to the south-eastern corner of Plot 63 of Government Survey Plan Sheet No. XLV.42 (north-west of Kissonerga village). Area "B": All that area within a radius of 300 yards on either side of the Ktima-Coral Bay road and commencing from a straight line (south-east of Kissonerga village) from the wheel-well on plot 332 to the south-western corner of Plot 494 of Government Survey Plan Sheet No. XLV.42; thence south-eastwards and south-westwards and ending on a straight line from the point where the ditch crosses Plot 111 to the most western corner of Plot 467 of Government Survey Plan Sheet No. XLV.50 (north of Lemba village).	
Area "C": All that area within a radius of 300 yards on either side of the Ktima-Coral Bay road and commencing from the bridge near the
