THE SOIL CONSERVATION LAWS, 1952 AND 1956.

NOTICE UNDER SECTION 9.

Pursuant to section 9 of the Soil Conservation Laws, 1952 and 1956, it is hereby notified that, with the approval of the Governor, a Soil Conservation Division has been formed in respect of the areas lying within the following boundaries, that is to say :—

Area "A".

All those areas of land at the locality "Paleomylos" in the village of Trimiklini, in the District of Limassol, comprising plots Nos. 302, 301, 283/1, 283/2/1, 283/2/2, 283/3, 283/4 and 283/5 of the Government Survey Plan No. XLVII.29.

Area "B".

The area lying within the following boundaries, that is to say :—

The boundary commences at the most northern point of plot No. 240 of the Government Survey Plan No. XLVII.29, locality "Pamboula", which point is on the Trimiklini-Platres main road and proceeds south-eastwards, southwards and westwards along the boundaries of and including the said plot, plots Nos. 239, 440, 534, 442, 493, 495, 497, 496, 237/1, 236/5, 236/6 and 197/1 of the said plan, to the south-eastern corner of the last mentioned plot, which corner is on the said main road ; thence southwards along the boundaries of and including the said plot, plots Nos. 196, 206, 213, 214, 218, 217/1, 217/2 and 221 of the said plan, to the most western point of the last mentioned plot, which point is on the said main road ; thence southwards along the said main road to the south-eastern corner of plot No. 461 of the Government Survey Plan No. XLVII.37 ; thence in a southerly direction along the boundaries of and including the said plot, plots Nos. 464/2, 464/1, 465, 467, 466, 457, 456, 455, 454, 453, 444, 445, 420, 418 and 557 of the said plan to the most southern point of the last mentioned plot ; thence in a northerly direction along the boundaries of and including the said plot, plots Nos. 422/1, 423, 424, 440/1, 438, 437/1, 480, 481, 512, 513, 514 and 517 of the said plan, plots Nos. 222, 226, 227, 223, 211, 208, 196, 246, 245, 244/1, 244/3, 287 and 240 of the Government Survey Plan No. XLVII.29 to the point of commencement.

Area "C".

All those areas of land at the locality "Miloudhes" in the village of Trimiklini, in the District of Limassol, comprising plots Nos. 144/1, 144/2, 144/3, 144/4, 144/5, 144/6, 144/7, 148, 149, 150, 154, 155 and 156 of the Government Survey Plan No. XLVII.37.

The said area described in Schedules A, B and C are more particularly defined as the areas coloured yellow on the Government Survey Plan marked "TRIMIKLINI SOIL CONSERVATION DIVISION" dated the 28th November, 1956, signed by the Acting Director of Agriculture and deposited in his office at Nicosia.

APPENDIX.

It is proposed to improve the existing terraces, to reconstruct most of the dry stone walls, to level the land for bench terracing purposes, and to carry out ripping, rock-raking and ploughing. Further, irrigation channels will be opened at suitable points to command the area.
