NOTICE UNDER SECTION 7.

Whereas by Notification published under No. 466 in Supplement No. 3 to the *Gazette* of the 7th June, 1956, the Governor declared under sections 2, 3 and 5 of the Land Acquisition Law the carrying out of the Greater Nicosia Water Supply Scheme to be an undertaking of public utility;

And whereas the Commissioner of Nicosia and Kyrenia by a notice published under Notification No. 909 in Supplement No. 3 to the *Gazette* of the 20th September, 1956, gave particulars of the properties (hereinafter referred to as "the properties") required in connection with the aforesaid undertaking ;

And whereas the Commissioner of Nicosia and Kyrenia forwarded to the Governor's Deputy the required recommendations, plans and particulars together with a report that no objections have been made;

And whereas the Governor's Deputy has approved the plan and particulars submitted, and has considered it expedient, having regard to the circumstances of the case, that the properties be acquired :

Now, therefore, in exercise of the powers vested in the Governor by section 7 of the Land Acquisition Law, the Governor's Deputy hereby sanctions the acquisition of the properties under the provisions of the said Law.

THE PENSIONS LAW.

REGULATIONS MADE UNDER SECTION 3.

In exercise of the powers vested in him by section 3 of the Pensions Law, His Excellency the Governor, with the advice of the Executive Council and with the sanction of the Secretary of State, has been pleased to make the following regulations :—

1. These Regulations may be cited as the Pensions (Amendment No. 2) Regulations, 1956, and shall be read as one with the Pensions Regulations (hereinafter referred to as "the principal Regulations") as from time to time amended.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 16) 1956.

ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in His Excellency the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 16) 1956, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of 26th November, 1955, I, Warren Frederick Martin Clemens, Commissioner of Nicosia and Kyrenia, do hereby give notice that in the interests of public order and safety and for maintaining supplies and services essential to the life of the Community, have taken possession with immediate effect of the land specified in the Schedule hereto until further notice.

2. The authority using the land in pursuance of this Order is entitled to do thereon or in relation thereto such acts as may be necessary for the purposes of their occupation.

3. The exercise of any right of wy over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of any interest in the land or otherwise is hereby prohibited during the period this order shall remain in force.

Schedule.

(a) The privately owned well and land situated in Liveras village, Kyrenia District, on Part of Plot 31 of Sheet Plan X.7.E. which well is more particularly defined as the area coloured blue on the plan signed by the Assistant Director of Hirings, Cyprus, dated the 8th December, 1956 and deposited in the Commissioner's Office, Nicosia.

(b) The waylowe for a water pipeline on part of Plot Nos. 31, 32, 33, 34, and 25 of Sheet Plan X.7.E. and Part of Plot No. 25 of Sheet Plan V.63.E., Liveras village, Kyrenia District, which said wayleaves are more particularly defined as the area coloured blue, on the plan signed by the Assistant Director of Hirings, Cyprus, dated the 8th December, 1956, and deposited in the Commissioner's Office, Nicosia.
