ORDER IN COUNCIL No. 2825

MADE UNDER SECTION 3.

In exercise of the powers vested in him by section 3 of the Forest Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :—

1. This Order may be cited as the Minor State Forest (Tylliria Group) (Amendment) Order, 1956, and shall be read as one with the Minor State Forest (Tylliria Group) Order, 1941 (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Minor State Forest (Tylliria Group) Orders, 1941 and 1956.

2. The area of land specified in the Schedule hereto is hereby declared to be no longer Minor State Forest, for the purposes of the Forest Law, and paragraph 1 of the Schedule to the principal Order shall be read subject to the Schedule hereto and the plan (Government Survey Plan Serial No. 1232) referred to therein and the plan referred to in the Schedule hereto shall be considered as one.

THE HOTELS LAW.  
CAP. 104 AND LAW 33 OF 1952.

It is hereby notified that in exercise of the powers vested in him by section 3 (2) (a) of the Hotels Law, His Excellency the Governor has been pleased to appoint the following persons to the Hotels Board for the purpose of the said Law and Regulations made thereunder as from the 21st February, 1956 :—

The Director of Public Relations.

*Members :*

The Director of Public Works (or his representative).

The Director of Medical Services (or his representative).

The Commissioner, Limassol (or his representative).

The Official Receiver and Registrar.

Mr. Theseus George Tavernaris of Nicosia.

Mr. Renos Odysseus Evryviades Wideson of Nicosia.

The aforementioned persons when sitting together with Mr. George Hercules Skyrianides, a nominee of the Pancyprian Hotel Keepers' Association under section 3 (2) (b) of the Law, shall constitute the Hotels Board :

Provided that when dealing with any hotel situated within the limits of any municipal corporation, a person nominated by the Council of such corporation shall be included in the Board as an additional member.

Notification No. 89 published in Supplement No. 3 to the *Gazette* of the 25th February, 1953, as amended by Notification No. 465 published in Supplement No. 3 to the *Gazette* of the 22nd July, 1954, and Notification No. 628 published in Supplement No. 3 of the *Gazette* of the 28th October, 1954, are hereby cancelled.

**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)  
(CYPRUS) ORDER, 1946.**

**ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.**

In exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force in consequence of the Supplies and Services (Continuance) Order, 1955), His Excellency the Governor by this Order, orders as follows :—

1. Subject to the restrictions and conditions contained in the First Schedule to this Order, the use, for military purposes, of the land and property specified in the Second Schedule (hereinafter referred to as "the land") during the period of six months from the date of this Order is hereby authorized.

2. The persons using the land in pursuance of this Order are entitled to do thereon or in relation thereto such acts as may be necessary for such military purposes.

3. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this Order shall remain in force.

**FIRST SCHEDULE.**

1. The land shall be occupied and used for military purposes only.

2. At the expiration of this Order the land shall be restored to the persons entitled thereto free of any erection, structure or construction erected or constructed thereon after the making of this Order.

3. Compensation shall be paid to the persons having an interest on the land for its use and occupation under this Order.

**SECOND SCHEDULE.**

All those privately-owned lands in the village of Perivolia, that is to say :—

The land forming part of plots Nos. 97 and 99/2 of the Government Survey Plan No. L/47, more particularly defined as the area coloured red on the plan signed by the Assistant Director of Hirings, Cyprus, and dated the 8th February, 1956, a copy of which has been deposited in the office of the Commissioner, Larnaca.
