THE EMERGENCY POWERS ORDERS IN COUNCIL,
1939 AND 1952.

REGULATIONS MADE BY THE GOVERNOR UNDER SECTION 6.

In exercise of the powers conferred on me by section 6 of the Emergency Powers Orders in Council, 1939 and 1952, I, the Governor, do hereby make the following Regulations :—

1. These Regulations may be cited as the Emergency Powers (Public Safety and Order) (Amendment No. 4) Regulations, 1956, and shall be read as one with the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1956 (hereinafter referred to as " the principal Regulations "), and the principal Regulations and these Regulations may together be cited as the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 4) 1956.

Amendment
of Regulation
2 of the

Regulations.

2. Paragraph (1) of Regulation 2 of the principal Regulations is hereby amended by the insertion therein, in their proper alphabetical place, of the following definitions :—

“ ‘ bomb ’ includes any part of a bomb and every adaptation or preparation of a bomb ;

‘ grenade ’ includes any part of a grenade and every adaptation or preparation of a grenade ; ”.

3. The principal Regulations are hereby amended by the insertion therein, immediately after Regulation 55, of the following new Regulation :—

“ Prohibi-
tion of
importation,
etc., of
appliances
for filling
cartridges.

55A. Save under a special permit granted by the Commissioner of Police, no person shall import, sell or otherwise dispose of, or have under his control or in his possession, any appliance which is capable of use for filling shotgun cartridges.”.

Amendment
of Regula-
tion 61 of the
principal
Regulations.

4. Regulation 61 of the principal Regulations is hereby amended as follows :—

(a) by the deletion therefrom of sub-paragraph (a) of paragraph (1) thereof and the substitution therefor of the following sub-paragraph :—

“ (a) declares, commences, takes part in or otherwise acts in furtherance of an illegal strike ; ” ;

(b) by the deletion from paragraph (3) thereof of the definition of “ illegal strike ” and the substitution therefor of the following definition :—

“ ‘ illegal strike ’ means any strike or lock-out which has any object other than, or in addition to, the furtherance of a trade dispute ; ”.
