THE EMERGENCY POWERS (COLLECTIVE PUNISHMENT)
REGULATIONS, 1955 TO (No. 1) 1955.

ORDER MADE UNDER REGULATION 3.

I, the Commissioner of Nicosia, in exercise of the powers vested in me by Regulation 3 of the Emergency Powers (Collective Punishment) Regulations, 1955 to (No. 1) 1955, and with the approval of the Governor, do hereby order that the shops specified in the First Schedule hereto, which are situated in the area, the boundaries of which are described in the Second Schedule hereto, shall be closed and kept closed until this Order be revoked.

FIRST SCHEDULE.

The shops at:—

HIPPOCRATES Street, Nos. : 35, 37, 39, 46, 50, 54.

AESCHYLUS Street, Nos. : 9, 11, 25A.

ONASAGORAS Street, No. 24, and the shop known as the New Pharos Confectionery shop.

APOLLON Street, No. 2.

LEDRA Street, Nos. : 181, 200, 202, 204.

ARSINOE Street, Nos. : 90, 92.

SECOND SCHEDULE.

From the Southern end of Ledra Street along Regaena Street—up Phokion Street to Arsinoe Street, along Sappho Street, down Aeschylou Street to Constantine Paleologou Street and back to the Southern end of Ledra Street.

THE EMERGENCY POWERS (COLLECTIVE PUNISHMENT)
REGULATIONS, 1955 TO (No. 1) 1955.

ORDER MADE UNDER REGULATION 3.

I, the Commissioner of Nicosia, in exercise of the powers vested in me by Regulation 3 of the Emergency Powers (Collective Punishment) Regulations, 1955 to (No. 1) 1955, and with the approval of the Governor, do hereby order that the dwelling-houses specified in the First Schedule hereto, which are situated in the area, the boundaries of which are described in the Second Schedule hereto, be closed and kept closed and unavailable for human habitation for a period of three months from the date of the making of this Order.

FIRST SCHEDULE.

The dwelling houses known as:—

HIPPOCRATES Street, Nos. : 41, 48, 52.

AESCHYLUS Street, Nos. : 1, 2, 3, 4, 5, 6, 7.

SECOND SCHEDULE.

From the Southern end of Ledra Street along Regaena Street—up Phokion Street to Arsinoe Street—Onassagoras Street to Sophocles Street into Solon Street, along Sappho Street, down Aeschylou Street to Constantine Paleologou Street and back to the southern end of Ledra Street.
