1. This Order may be cited as the Curfews (Nicosia District No. 6)

No person within the area of Nicosia Municipality bounded by Constantine Paleologus Avenue, up Onesilus Street to Archmandrites Kyprianos Avenue, down Archmandrites Kyprianos Avenue to Patriarchis Gregoris Street, down Said Pasha Street to Isaacios Komninos Street, down Isaacios Komninos Street and Orhaniye Street to Theseus Street and along Nikiforos Phokas Street to the end of Constantine Paleologus Avenue, shall be out of doors on the dates and during the hours prescribed in the Schedule hereto except under the written authority of the Commissioner of Police, or the Superintendent of Police in charge of the area:
- 3. Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 21st day of March, 1956.

2. No person within the district boundaries of the District of Nicosia shall be out of doors between the hours prescribed in the Schedule hereto except under the authority of a written permit granted by the Commissioner of Nicosia, or the Assistant Commissioner of Police in charge of the area:

Provided that this Order shall not apply to any member of the Executive

Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 25th day of March, 1956.
