ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955, and delegated to me by Notification No. 736 published in Supplement No. 3 to the Gazette of the 26th November, 1955, I give notice that in the interests of public order and safety I have taken possession until further notice of the land specified in the Schedule hereto.

2. The use of the said land by Her Majesty's Forces for military purposes

is hereby authorized.

3. The persons using the land in pursuance of this Order are entitled to do thereon or in relation thereto such acts as may be necessary for such

military purposes.
4. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this Order shall remain in force.
