# THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 4) 1956.

# ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I give notice that in the interests of public order and safety I have taken possession until further notice of the land specified in the Schedule hereto.

2. The use of the said land by Her Majesty's Forces for military and security purposes is hereby authorized.

3. The persons using the land in pursuance of this Order are entitled to do thereon or in relation thereto such acts as may be necessary for such military and security purposes.

4. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this order shall remain in force.

### SCHEDULE.

The property at Varosha, Ayios Nikolaos Quarter, Block D comprising part of plots 962 and 963 of the Government Survey Plans Nos. XXXIII. 12.3.III and XXXIII.12.6.I more particularly defined as the area coloured red on the Government Survey Plan dated 22nd March, 1956, and signed by the District Lands Officer, Famagusta.

#### ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I give notice that in the interests of public order and safety I have taken possession until further notice of the land specified in the Schedule hereto.

2. Her Majesty's Forces are hereby authorized to do in relation to the land anything, which the owner or any person having an interest in the land would be entitled to do by virtue of such ownership or interest as may be necessary for security purposes.

3. The exercise of any right relating to the land which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this order shall remain in force.
