## ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 618 published in Supplement No. 3 to the *Gazette* of the 13th October, 1955, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Nicosia and Kyrenia District No. 1L) Order, 1956.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Assistant Commissioner of Lefka, or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 3rd day of April, 1956.

From 0400 hours on 3rd April, 1956, to 0600 hours on 4th April, 1956.

## ORDER MADE UNDER SECTION 2.

1. This Order may be cited as the Curfews (Limassol District No. 7) Order, 1956.

2. No person within the area of Limassol Municipality bounded by Victoria street, up to the junction with Gladstone street, along to the junction with George VI street, along to the junction with Andreas Themistocleous street to Kanaris street to Hellas street to Ktorides street and up to the junction with Victoria street, shall be out of doors on the date and during the hours prescribed in the Schedule hereto except under the written authority of the Commissioner of Limassol, or the Senior Superintendent of Police, Limassol :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 27th day of March, 1956.
