## ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 618 published in Supplement No. 3 to the *Gazette* of the 13th October, 1955, I do hereby order as follows :---

1. This Order may be cited as the Curfews (Limassol District No. 9) Order, 1956.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Limassol or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

This Order shall come into force on the 1st April, 1956.

#### FIRST SCHEDULE.

The area of the town of Limassol within the following boundaries :-From the sea immediately south of the junction of Byron Street and Sir Herbert Richmond Palmer Street ; along Byron Street to its junction with Canning Street ; along Canning Street and Gladstone Street to the junction of Gladstone Street with Ayia Phylaxis Street ; along Navarinou Street to its junction with Eleftheria Street ; along Eleftheria Street to its junction with Victoria Street ; and along Victoria Street and Spyro Araouzo Street to the Customs entrance.
